Application Process:

1. Student:
 - Indicate class selection (*note: classes are all year long except CWEST & XIP*)
 - If you are applying for Advanced Health Occupations, request signature from instructor.
 - Complete and sign section titled Student.
 - Request Parent/Guardian's permission and signature.
 - Turn in application to school counselor.
2. Parent/Guardian:
 - Complete and sign section titled Parent/Guardian.
3. Counselors:
 - Verify that the student is or will be at least 16 yrs of age at the time program begins or 14 yrs for XIP.
 - Verify that student has demonstrated maturity required to attend an off campus program.
 - Review transcript & graduation requirements and verify that participation in this City Campus Program, which is a year long except CWEST & XIP, supports the student's high school and post high school plans.
 - Attach "Student Verification Form".
 - Complete and sign section titled Counselor.
4. **Please send completed application with "Student Verification Form" attached** via district mail to City Campus at MS 31-671 or by U.S. mail to: City Campus Program, Dept. of Career & Technical Education, Seattle Public Schools MS 31-671, P.O. 5. The City Campus Coordinator will review application.
6. Student, parent/guardian, counselor, registrar and XIP teacher will be notified of the student's status.
7. CTE will cross enroll students to City Campus High and schedule the student into the appropriate course.
