SEC. 725. MACNAHA.

Ujeeddooyinka qoraal hoosaadkan:

- (1) Erayada "diiwaangelinta" iyo "isdiwaangelinta" oo ay ka mid ah yihiin ka qeybgalka fasallada iyo ka qeyb qaadashada buuxda ee waxqabadka dugsiga.
- (2) Ereyga "carruurta iyo dhalinyarada hoy la'aanta ah" –
  - (A) waxaa loola jeedaa shaqsyaadka aan haysan degenaansho rasmi ah, oo joogto ah, oo ku filan habeenkii oo ay ku noolaadaan (taasoo macnaheedu yahay qaybta 103 (a) (1)); iyo (B) oo ay ku jiraan–
    - (i) carruurta iyo dhalinyarada la wadaagaya guryaha dadka kale sababtuna tahay guri la'aan, dhibaato dhaqaale, ama sabab la mid ah; oo ku nool motels, hoteello, jardiinooyin dukaameysan, ama xeryo ay sabab u tahay la'aanta deegaanno kale oo ku filan oo la heli karo; aad ku nool yahay guryaha gurmadka deg-deg ah ama hoy ku-meelgaar ah; ama looga tagay isbitaalada;
    - (ii) carruurta iyo dhallinyarda leh hoy rasmi ah oo habeenkii oo ah meel dadweyne ama gaar loo leeyahay oo aan loogu talagalin ama caadiyan loo istcimaalo hoy caadi ah oo aadanaha loo adeegsado (iyada oo la macno yahay qaybta 103 (a) (2) (C));
    - (iii) carruurta iyo dhalinyarada ku nool gawaarida, jardiinooyinka, meelaha dadweynaha, dhismayaasha la dayacay, guryaha liita, basaska ama tareenka, ama meelaha la midka ah; iyo
    - (iv) carruurta guurayaasha ah (sida ereyga lagu qeexay qaybta 1309 ee Sharciga Dugsiga Hoose iyo Sare ee 1965) kuwaasoo u qalma hoy la'aan ujeeddooyinka cinwaan-hoosaadka maxaa yeelay carruurtu waxay ku nool yihiin duruufaha lagu qeexay faqradaha.(i) illaa iyo (iii).
  - (3) Ereyga "dhalinyarada aan lala socon" waxaa ku jira qof dhalinyaro ah oo aan ku jirin gacanta waalidka ama mas'uulka.
