

## 2019-20 ORCA Card Conditions of Use

By accepting your ORCA Card, you agree to adhere to The Basic Rules of Seattle Public Schools as well as Metro's Code of Conduct and Safety & Security tips.

### **For the Safety and Comfort of All Transit Riders:**

Everyone who pays his/her required fare is welcome to ride the bus or light rail. Everyone who rides the bus must respect the rights of other customers. Metro has a Code of Conduct that governs behavior on the bus and is enforced by local police jurisdictions and Metro Transit Police.

**Any of the following behaviors while riding the bus violates Metro's Code of Conduct. Violators may be subject to arrest, fine or ejection.**

• Refusing to pay proper fare	• Vandalizing transit property
• Drinking alcoholic beverages	• Blocking the aisles
• Radio or tape playing without earphones	• Smoking
• Lying down or occupying more than one seat	• Carrying flammable materials
• Harassing driver or other riders	• Spitting
• Fighting or using profanity	• Hanging or swinging on bars or stanchions
• Littering or creating unsanitary conditions	• Extending an object or portion of one's body through the door or window

**Violation of The Basic Rules of Seattle Public Schools, Metro's Code of Conduct, Metro's Safety & Security tips or any of the below applicable conditions may result in temporary or permanent loss of your ORCA card and/or bus privilege.**

### **Additional Conditions:**

- All ORCA cards with the Seattle Public Schools logo on them are property of the Seattle School District.
- ORCA Cards will be issued, by serial number, to each eligible student for their use only.
  - *Cards are not to be transferred to or used by anyone other than the assigned student.*
- Cards will be blocked (made invalid) if the student becomes ineligible for transportation, violates the conditions of use, or stops attending their Seattle Public School/program.
- It is the student's responsibility to keep their card in good condition and to immediately report lost, stolen or damaged cards.
- A fee of \$5.50 will be charged for the student's first replacement card.
- A fee of \$25.00 will be charged for any subsequent replacement card.
- Additional funds or other products should not be added to the District issued card. *Refunds of funds or products added to cards that are the property of the district are not guaranteed.*
