SEC. 725. Qeexida .

Ujeedooyinka caawinaada :

- (1) Ujeedada “*Diwaangelin*” ama “*diwaangelinta*” waxaa ku sii jira iska xaadirinta fasalka iyo ka qaybqaadasho buuxda dhamaan waxyaabah ka dhacaya dugsiga.
- (2) Ereyga ah “*Caruurta iyo dhalinyarada guri la`aanta ah*”
 - (A) Waxaa loola jeedaa shakhsiyaadka aan haysan , joogtp, iyo degaan ay ku hoydaan habeenkii (within the meaning of section 103(a)(1));
 - (B) Ay ku jitaan.
 - (i) Caruurta iyo dhalinyarada oo la wadaagayaan guri kuwa kale uu ka lumay gurigooda ,dhaqaalo daro awgeed , ama siyaabo u eg; oo degan albeergo , hotelo, gaarida banaanka , ama ama kuwa dhulka seexdo ama aan heysan meel laga helayo waxyaabaha guriga ; ama degan hoy ku meel gaar ah ama hoyga ku meel gaarka ah; ama cisbitaalka lagu xaroodo;
 - (ii) Caruurta iyo dhalinyada leh hoy habeenkii oo ka dhaxeeya dadka oo idil ama mid khaas ah lakiinse aan u habaysneyn meel caadi ah oo qof uusan seexan Karin (Macnaha qaybta 103(a)(2)(C));
 - (iii) Caruur iyo dhalinyaro ku noog gaari, banaan, meel dadka ka dhaxeeyso, guri laga guuray, guri aan heysan wixii laga doonayey , bas ama or goobta tareenka , ama goobo la mida: iyo
 - (iv) Caruurta garguurata (sida macnaha cadeyneysa qeybta 1309 ee dugsiga hoose iyo dugsiga sare sharciga waxbarashada ee 1965) waxaa xaq u leh caruurta aan heysan hoy sababtoo ah caruurtaas oo ku jira dhibaato xagga hoyga waxaa ka mid ah qodobada (i) ilaa (iii).
- (6) Mudada “*dhalinyarada keliya*” ay ku jiraan *dhalinyarada oo aan la socan waalidka ama masuulka.*
