Explanation:

- Copier data cannot be disaggregated by teacher; therefore, determining actual usage by science classrooms is not possible.
- An analysis is provided comparing the overall usage at each school from academic years 2016-17 and 2017-18 in an attempt to demonstrate overall trends in waiver schools vs. non-waiver schools.
- New schools (Robert Eagle Staff and Meany) were not open during 2016-17 and therefore were not included in this analysis. Mercer is the only waiver school that used Amplify during the 2016-17 school year. Removing them from the equation results in a 0.2% change.

Conclusions:

- On average, copier usage across all schools dropped 12.6% from 2016-17 to 2017-18.
- Waiver schools saw a greater decrease in usage (-2.1%) compared to non-waiver schools.
- Anecdotal evidence from teachers leads to the conclusion that printing worksheets and articles from Amplify equals the amount of copies made during the pre-waiver era, as most teachers produced their own worksheets and articles.
- Due to the wide range of uncontrollable variables, the only conclusion that may be drawn from this analysis is that waiver schools did not see a significant effect of utilizing Amplify curriculum in their science classrooms in 2017-18 compared to academic year 2016-17.
