## **Meeting commenced – Review of Instructional Materials Candidates**

The Adoption Coordinator welcomed the Committee.

All members in each grade band reviewed the top 3 candidates. Subgroups spent 45 minutes per candidate to have a sense of each of the top candidates.

## **Protocol used:**

A facilitator for each candidate program was selected based on the committee members having reviewed the materials during previous meetings and having an understanding of how to navigate the program. These facilitators were asked to be impartial guides, not advocates, for each of the programs.

10 minutes: All quietly reviewed the printed resources

15 minutes: The facilitator gave a guided tour of this instructional resource.

They showed the resources, gave the big picture, guided a click-around of the online sites.

10 minutes: Members spent some time exploring

Guiding Question: What would it look like from the vantage of a teacher?

Dig into the student materials (simulations, assessments, worksheets, readings) to gather evidence.

10 minutes: Facilitator shared each category of their original evaluation, addressing strengths, weakness, and answering member questions.

After this period, the groups rotated to another candidate program to repeat the process. Facilitators were rotated out to allow them to review other programs.
