1. TITLE

Motion to waive Board Policy No. 2415 requirement to meet all state graduation requirements to allow participation in 2017 commencement exercises.

2. PURPOSE

This Board Action Report proposes a motion to waive the portion of Board Policy No. 2415, High School Graduation Requirements, which requires that a student must have met all state graduation requirements in order to participate in commencement exercises. This would allow students who have not passed the biology end-of-course exam to participate in commencement exercises with their class. This waiver would be for the graduating class of 2017 only.

3. RECOMMENDED MOTION

I move that the School Board waive the portion of Board Policy No. 2415, High School Graduation Requirements, requiring that all state graduation requirements are met, for the limited purpose of allowing students who are scheduled to graduate in June 2017, and who have met all requirements with the exception of the biology end-of-course exam, to participate in commencement exercises with their class.

4. <u>BACKGROUND INFORMATION</u>

a. Background

There are 109 high school seniors in Seattle Public Schools who have not passed the biology end-of-course exam, but have met all other assessment requirements. This is the first year that passing the biology end-of-course exam is a state graduation requirement and has been highly debated in all levels of the state. Right now, there is a good chance that the Legislature will act and eliminate passing the biology end-of-course exam as a requirement to receive a high school diploma. However, this action will likely not come in time for the affected students to walk in the graduation commencement exercise with their class. This motion will allow these students to participate in commencement, but they will still have to meet all state and district requirements to receive a diploma from Seattle Public Schools.

There is a movement across the state of Washington to compel the Legislature to eliminate the biology end-of-course exam as a graduation requirement. Notably, on May 11, 2017, the Washington State Board of Education adopted a resolution at its Board meeting in Walla Walla urging immediate action by the Legislature to eliminate the biology end-of-course exam as a graduation requirement. The State Board of Education endorses removing the graduation requirement effective immediately to include the high school graduating class of 2017.

Although the probability is favorable that the Legislature will act and allow students who have not passed the biology end-of-course exam to receive high school diplomas, the decision will not occur in time to allow students to plan for, and participate in, graduation commencement activities. If the Legislature does not act and remove passing the biology end-of-course exam as a state graduation requirement, students who were allowed to walk under this limited waiver will still need to meet the requirement to receive a high school diploma.

The high school principals of Seattle Public Schools were surveyed to inquire whether they supported seniors who have not passed the biology end-of-course exam to participate in the 2017 commencement exercises. Out of thirteen (13) high school principals, ten (10) high school principals support allowing the students to participate. Of the principals who did not support the participation, the general concern was that the concession was unfair to the students who worked hard to pass the exam.

b. Alternatives

Do not waive the policy requirement that all state graduation requirements, including the biology end-of-course exam, must be met to participate in 2017 commencement exercises. This is not recommended because there are 109 students who have met all other assessment requirements other than the biology end-of-course exam that would not be able to walk in commencement exercises with their class. Given the fact that the likelihood is favorable that the Legislature will change the requirements for the class of 2017, not allowing the students to walk in commencement would appear very unfair after the fact if the change in the law does occur as anticipated.

c. Research

109 high school seniors would not be able to participate in commencement exercises because they have not passed to biology end-of-course exam, but have met all other assessment requirements.

10 of 13 high school principals support student partipation in commencement exercises.

The Washington State School Board of Education supports eliminating the biology endof-course exam as a class of 2017 graduation requirement and passed a resolution to urge the Legislature to take action.

10. POLICY IMPLICATION

This motion implicates the application of Board Policy No. 2415, High School Graduation Requirements. The policy couples the participation in commencement exercises with the receipt of a high school diploma and this motion would allow students to participate in commencement exercises although they have not passed the biology end-of-course exam, which is a requirement to receive a high school diploma.

12. <u>TIMELINE FOR IMPLEMENTATION</u>

Upon approval of this motion, students who have met all state and district graduation requirements except passing the biology end-of-course exam will be informed that they are able to participate in the 2017 graduation commencement exercises with their class.

HIGH SCHOOL GRADUATION REQUIREMENTS

Policy No. 2415 January 4, 2017

Page 1 of 3

It is the policy of the Seattle School Board that in addition to meeting all graduation requirements set forth by the State of Washington, all District high school students meet the following requirements in order to graduate:

- Students in the class of 2020 or earlier must have a minimum of 21 credits in order to graduate; students in the class of 2021 or beyond must have a minimum of 24 credits in order to graduate. Students are urged to examine their post-high school plans, and to take the appropriate credits that will allow them to achieve their postgraduate goals. Additionally, students are encouraged to gain proficiency in many areas of the curriculum.
 - Individual schools may require additional credits for graduation; to do so, the school must receive a written waiver from their Executive Director of Schools, the Assistant Superintendent for Teaching and Learning, and the Superintendent.
- 2. The Board recognizes the importance and is supportive of community service by requiring students to participate in service learning activities, which are jointly developed by the District and school sites. Students are required to complete 60 hours of service learning before graduation.
- 3. In order to graduate, students will be required to have at least a 2.0 or above cumulative GPA and a 2.0 cumulative GPA or above in all courses in English Language Arts, Mathematics, Social Studies, and Science. For purposes of this board-adopted graduation requirement <u>only</u>, the GPA will be calculated in a way that treats an "E" grade the same as an "N" grade.

Students Completing the International Baccalaureate (IB) Diploma Program

Beginning in Fall 2011, students who fulfill the requirements of an international baccalaureate (IB) program are considered to have met state high school graduation standards, so long as:

- 1. The student meets the requirements for the certificate of academic achievement or the certificate of individual achievement;
- 2. The student meets the provision regarding study of the Constitution of the United States and the Constitution of the state of Washington; and
- 3. The student meets all graduation requirements required by Seattle Public Schools or by the student's school that are in addition to state minimum requirements, unless those requirements are waived by the student's principal or designee.



HIGH SCHOOL GRADUATION REQUIREMENTS

Page 2 of 3

Fulfilling the requirements of an international baccalaureate program means the student has:

- Completed and passed all required IB courses as scored by the school;
- 2. Passed all internal assessments as scored by the school;
- Successfully completed all required projects and products as scored by the school; and
- Completed the final examinations administered by the international baccalaureate organization in each of the required subjects under the IB diploma program.

A student and his/her parent or guardian will be required to sign the "International Baccalaureate Option Form" indicating that the student and family understand that the waiver from state minimum graduation requirements only applies for students who fulfill the requirements of the IB program; should a student fail to meet the requirements, or if a student leaves the program prior to completion, he or she may be required to fulfill state and Seattle Public Schools minimum graduation requirements.

Graduation and Participation in Commencement

- 1. Students must be enrolled and attending a school for the semester immediately preceding graduation to be eligible to graduate from that school. Students who are participating in Running Start or who have properly obtained dual-enrollment in another school district or approved program may graduate from their affiliated District high school.
- 2. A student must have met all state graduation requirements or fulfilled the requirements of the International Baccalaureate program, and have met or waived all District graduation requirements, in order to participate in commencement, unless the student has a right to participate in commencement as a matter of state or federal law.

The Superintendent or the Superintendent's designee(s) shall annually create, post, and distribute a *Graduation Requirements Bulletin* for each graduating class detailing all graduation requirements, including requirements set forth by the State of Washington, a breakdown of the areas in which students must earn credit, and a process by which district requirements may be waived. The *Graduation Requirements Bulletin* and the *K-12 Counseling Manual* serve as the administrative procedures to further implement this Policy.

Commented [BRD1]: This motion will waive this portion of the policy for students in the class of 2017 who have not passed the Biology EOC exam. All other state and District graduation requirements must be met for participation in commencement.

Legislative Session Update

Legislative delay leaves us with a \$50m deficit

 1st Special Session started on Monday, April 24 has ended with no action

- Still expecting final budget at the end of June
- Predicting that McCleary is not solved in 2017
 session (looking more and more likely)

Legislative Session Update

 Based on preliminary House and Senate budgets we anticipate at least \$6m in Per Pupil Inflator additional funding available for restoration.

 Even most hopeful budget costs more than what is funded.



What to do with Last Minute New Revenue?

When the state budget is passed, AND IF we receive more revenue than anticipated, what should be done with that increase?

- SMART Goal funding
- More for equity High Needs schools
- Fall enrollment/split classroom adjustments
- Middle School math
- Central admin restoration
- Other

Recommendations will be part of the June budget work session.

Reminder of additional funding for staffing in 2016-17

- \$2.3m from \$11m one time funding
- \$2.0m for fall enrollment adjustments
- \$1.8m for fall class splits
- \$6.1m additional staffing

Currently not funded in 2017-18 budget



Two Tier Transportation update

- Waiting for action by the City
- June 15th deadline for approval by the City to enable SPS to move forward for 2017-18
- Notification for families and schools on June 16th
- Ongoing cost beginning in 2018-19



\$2.8m for High Needs Schools Update

- Schools receiving funding have been identified as Tier I or Tier II in Equity High Needs funding (Attachment to January 11, 2017 budget work session) analysis
- Schools will receive additional FTE and must provide a plan as to what FTE they need, and it must align to:
 - Opportunity gap efforts
 - MTSS
 - CSIP

Background on Enrollment (not waitlist) Staffing Adjustments

Background

- School staffing levels are historically examined three times each year:
 - February (initial budget allocations)
 - June (adjustments based on updated enrollment projections)
 - September (final adjustments based on actual enrollment)
- Our goal this year is to notify schools of any adjustments by 5 p.m. on Friday, June 16, 2017.
 - Last year, adjustments were announced on June 17, 2016.




Background on Enrollment (not waitlist) Staffing Adjustments

- Adjustments will be identified based on updated gradelevel enrollment projections for each school:
 - Potential adjustments will include both adding and pulling FTE,
 in order to better match staffing with projected enrollment.
 - The June process will address both General Education and Special Education staffing.
 - As in previous years, we will leave Core staffing levels constant.
- Schools will not receive any additional staffing adjustments until June 16.

Wait Lists – What are our policies and practices?

- Attendance area policy
 - Implemented as a result of problems with Choice/Free Market previous policy
 - More equitable
 - More predictable for families
- Option School policy
 - Allows for families to have alternatives to attendance area schools
- Waitlist moves are predicated on staffing, not just space capacity
- Waitlists for Option Schools continue to be moved based on ** available seats in classrooms

Waitlist Considerations

- Is there capacity within the WSS staffing allocation?
- Is there room to add another teacher/class?
- Would it create more split classes? Overage costs?
- Would it negatively impact/deplete other schools?



Waitlists Move Impacts

- Small number of families positively impacted
 - To date about 6,000 of students were on waitlists for 2017-18.
 - 3,000 students have received their first choice!
 - 2,200 students currently on waitlists
- Larger number of families negatively impacted
 - These schools/families don't know that they would be impacted and we haven't heard from them, but we will



Waitlist - Budget Impacts

Moving 527 students on the waitlist (schools that have physical capacity), which would result in:

- 19 schools would lose staff
- 8 schools would gain staff
- Cost to backfill for all lost staff is \$1.9m/17.8 FTEs
- Need to have the <u>whole picture</u>, not incremental, so we can ensure its though an equity lens

Waitlist Move HR Impacts

- 19 schools would lose staff
 - These staff would need to be reassigned, likely not in the same school
 - Most of the school positions are now filled, and this would create significant movement
- 8 schools would gain staff
 - Likely would be some of the staff from the 19 schools above



Waitlists - Opportunities for Improvement

- What schools should have a waitlist (i.e. only those not already over physical space capacity), refine list of schools/grades
- Clarify what "capacity" means
- Clarify timeline for decisions
