General Fund

For October 2018, the ending fund balance is \$188.1M. This compares to \$144.8M for October 2017. October enrollment of 52,228 is less than adopted budget for 2018-2019 by 836 FTE. Revenues are \$213.6M YTD, compared to \$174.5M last year (see Pg. 4). State revenues of \$57.2M are up approximately \$26.3M over the previous year, reflecting increased state funding. Expenditures of \$140.1M are up \$16.4M over the previous year due primarily to increased staff expenses (see Pg. 4).

Capital Projects Fund

The Capital Projects Fund balance is \$112.4M compared to \$95.3M in the prior year. Fund balance is comprised primarily of BEX IV \$47M, BTA III \$40.2M, BTA IV \$3M, and Other Programs \$18.7M. Revenues are \$78.4M, consisting primarily of property taxes earnings from the BEX IV levy \$45.5M, and BTA IV levy \$31.1K. Expenditures of \$12.2M are comprised principally of BEX IV \$4.5M and BTA IV \$6.6M (see Pg. 10).

Debt Service Fund

At October 2018, the fund balance is \$1.3M. Fund balance is restricted for payments of the principal and interest related to the 2010 refunding bond.

Associated Student Body

The Associated Student Body Funds represent monies raised by student groups for cultural, athletic, recreational, and/or social purposes. Fund balance at October 2018 is \$4.5M compared to \$4.3M as of October 2017 (see Pg. 11). YTD Revenue is \$1.3M, and Expenditures are \$478K.

Private/Trust

The Trust Fund accounts are monies donated to the District for private purposes, primarily scholarships, and are governed by individual agreements. Fund balance at October 2018 is \$2.4M compared to \$2.2M as of October 2017.

Investments

The King County Pool net earned interest rate was 1.91% in October, compared to 1.15% of the previous year (see Pg. 9). The rate has gradually increased over the last year, following the general interest rate trend.

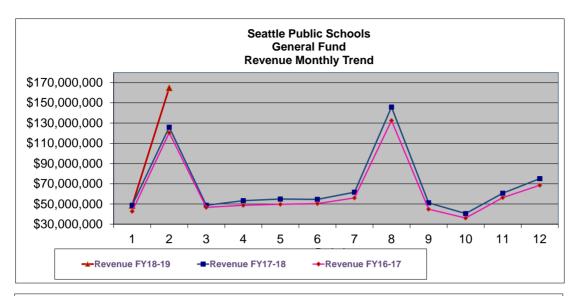
Seattle School District Average Annual Enrollment by Grade As of 10/31/2018

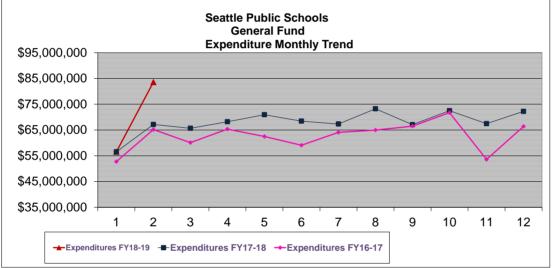
