#### IV. POLICY IMPLICATION

Board Policy No. 3130, Student Assignment, states that students shall have the opportunity to attend an elementary, middle, or high school in a designated attendance area based upon home address, unless the school designated by a student's home address does not have the appropriate services for the student's needs, as determined by the District.

Any changes to boundaries, geographic zones, or assignment rules subsequent to implementation of the Student Assignment Plan require Board action.

#### V. RECOMMENDED MOTION

I move that the School Board amend the proposed 2017-2018 Implementation Amendments to the 2013-2020 Growth Boundaries Plan to:

- 1) Implement grandfathering at the elementary school level for all current K-4<sup>th</sup> grade West Woodland Elementary School students living in area 126; and
- 2) Implement grandfathering for current 6<sup>th</sup> and 7<sup>th</sup> graders living in area 126 to allow those students to finish middle school at Hamilton Middle School.

#### VI. BOARD COMMITTEE RECOMMENDATION

This motion was not discussed by a Board committee.

#### VII. BACKGROUND INFORMATION

In the proposed 2017-2018 Implementation Amendments to the 2013-2020 Growth Boundaries plan, area 126 would move from the West Woodland Elementary School attendance area to Whittier. This amendment would allow current elementary school students and families living in these areas the choice to either stay at West Woodland or move to Whittier, thus minimizing disruption for these families. These students reside within the designated walk zone for either school.

There are currently 23 K-4 students eligible for grandfathering in area 126. Assuming some of these students choose to stay at West Woodland, the impact of this amendment would be increased enrollment over capacity at that school. Enrollment at West Woodland as of 9/19/2016 is 546 students, including the 23 students in area 126. The projected 2017-2018 capacity, given the mandate for lower class sizes, is 491 students. Allowing additional students to stay at West Woodland may lead to the need for additional portable space.

At the same time, Whittier Elementary would face additional capacity constraints if it received all 23 students in area 126. Enrollment at Whittier as of 9/19/2016 was 477 and the 2017-2018 capacity is 434. Whittier currently does not have any portables.

At the middle school level, this amendment would allow current  $6^{th}$  and  $7^{th}$  graders at Hamilton Middle School to remain at that school through the remainder of their middle school. This would have a minor impact on capacity issues at Hamilton, which is currently overcapacity. Enrollment at Hamilton as of 9/19/2016 is 1,200 students. The projected 2017-2018 capacity for Hamilton is 985 students.

This amendment would not grandfather current West Woodland students into Hamilton Middle School. Those students rising from elementary to middle school would follow the new feeder pattern to Whitman Middle School for area 126.

#### VIII.STATEMENT OF ISSUE

Whether to approve an amendment that would allow grandfathering for current students at West Woodland Elementary and Hamilton Middle School that live in area 126.

#### IX. ALTERNATIVES

1. Adopt current staff recommendation. This is not recommended as the amendment would minimize disruption to families living in the affected areas.


