I. <u>TITLE</u>

BTA IV Resolution 2016/17-4: Racial Imbalance Analysis for Magnolia Elementary School Renovation and Addition Project For Introduction:August 24, 2016For Action:September 7,
20162016February 1,

II. WHY BOARD ACTION IS NECESSARY

The D-5 form for the Magnolia Elementary School Renovation and Addition project is ready for submission to the Office of Superintendent of Public Instruction (OSPI) as a requirement for state funding assistance. A Board Resolution is required by OSPI as a part of the state funding assistance process to certify under WAC 392-342-025 that the project will not create or aggravate racial imbalance.

III. FISCAL IMPACT/REVENUE SOURCE

The Magnolia Elementary School Renovation and Addition project's funding source is from the BTA IV Levy, State of Washington Distressed School Grant and OSPI School Construction Assistance Program (SCAP). The anticipated SCAP funding is an estimated \$2.3 million dollars. This Resolution does not represent a specific expenditure.

IV. POLICY IMPLICATION

School Board Policy No. 6100, Revenues from Local, State, and Federal Sources, states in part: "It is the policy of the Seattle School Board to pursue systematically those funding opportunities that are consistent with district priorities from federal, state, and other governmental units, as well as from private and foundation sources." In addition, the policy states: "The Board agrees to comply with all federal and state requirements that may be a condition for the receipt of federal or state funds."

V. <u>RECOMMENDED MOTION</u>

I move that the School Board approve Resolution 2016/17-4 certifying that the proposed Magnolia Elementary School Renovation and Addition project will not create oraggravatebut will minimize racial imbalance as defined by WAC 392-342-025, as attached to the Board action report.

VI. BOARD COMMITTEE RECOMMENDATION

This motion <u>will was be</u> discussed at the Operations Committee meeting on August 16, 2016. The Committee moved this item forward to the full Board with a recommendation for approval.recommended______.

VII. BACKGROUND INFORMATION

The Office of Superintendent of Public Instructions (OSPI) is responsible for administering the School Construction Assistance Program (SCAP) which is OSPI's largest capital program and provides funding assistance for facility planning, new construction, and modernizations. Based on OSPI's work, the Legislature makes biennial appropriations to release state funds for school construction assistance through the D-Form approval process which include the primary documents that form the basis of any agreements between OSPI and the school districts receiving state funding assistance.

The Office of the Superintendent of Public Instruction Form D-5 requires a School Board Resolution to certify under WAC 392-342-025 that the project will not create or aggravate racial imbalance. If this resolution is not approved in a timely manner, then state funding assistance for this project will not be forthcomingprovided. SCAP funding for Magnolia Elementary School Renovation and Addition Project is estimated to be approximately \$2.3 million dollars.

The Enrollment Planning section of the Capital Projects and Planning department has identified a need for additional capacity in the Magnolia/West Queen Anne communityenrollment areas. They have recommended that Magnolia Elementary School be renovated, enlarged, and reopened <u>as a neighborhood attendance area school</u> in fall 2018 to meet projected capacity needs. When completed, the project will add 500 seats to the <u>central Magnolia/West Queen Anne enrollment Seattle</u> capacity.

<u>Under WAC 392-342-025</u>, <u>r</u>Racial imbalance in a greater than fifty percent minority, nonmultiracial school district such as Seattle Public Schools shall be defined (by current federalcategories) as existing:

- (a) When the combined minority enrollment of a school varies from the districtwide combined minority percentage by more than plus or minus twenty-five percentage points; or
- (b) When a school's enrollment of a single minority group with a districtwide enrollment of less than thirty percent exceeds fifty percent; or
- (c) When a school's enrollment of a single minority group with a district-wide enrollment of thirty percent or more exceeds the minority group's district-wide percentage by twenty percentage points or more.

<u>Analysis:</u> Current enrollment data shows that racial imbalance currently exists at the three nearby elementary schools from which the re-opened Magnolia Elementary School would likely draw students. The neighboring schools are: Catharine Blaine K-8 (less than one mile west of Magnolia Elementary), Lawton Elementary (one and a half miles north of Magnolia

Elementary), and Coe Elementary (three miles east of Magnolia Elementary in west Queen Anne). Magnolia Elementary School is planned to be a neighborhood attendance area school. Revised attendance area bBoundaries have yet to be determined finalized, hHowever, an analysis of four possible boundary scenarios drawn to include Magnolia Elementary School shows the racial make-up of the student enrollment at three neighboring schools from which. Magnolia Elementary School would will likely draw students should provide sufficient data to determine the racial make up that can be anticipated when Magnolia Elementary opens in the fall of 2018. be racially balanced and the enrollment at Lawton Elementary School improves from racially imbalanced to balanced, while the enrollment at Catharine Blaine K-8 School and Coe Elementary School remain racially imbalanced. Thus, the proposed project at Magnolia Elementary School will not aggravate the existing racial imbalance in student enrollment in the Magnolia/West Queen Anne enrollment areas as defined by WAC 392-342-025, but it will provide two racially balanced schools where currently none exist in the Magnolia/West Queen Anne enrollment area.

The foregoing justification The proposed boundaries were reviewed with the Office of the Superintendent of Public Instruction was discussed via conference call with (OSPI). OSPI has reviewed the revised resolution and confirmed that the intent of WAC 392-342-025 is being met (see attachment). The neighboring schools are: Catharine Blaine K-8 (less than one mile west of Magnolia Elementary), Lawton Elementary (one and a half miles north of Magnolia Elementary), and Coe Elementary (three miles east of Magnolia Elementary in west Queen Anne).

A comparison of the student enrollment data for the 2015–16 school year at these three schoolsreveals a variation of 25–28 percent from the "district wide" total minority percentage (see-Table 1). It is evident that the total minority racial make-up is similar between the threeschools. This same analysis was performed for 2011-2015/16 school years (5-year average) and 2000-15/16 school years (16-year average) and the results proved similar. Since studentenrollment for the new school will most likely draw students from these three schools, it can be reasonably concluded that the re-opening of Magnolia Elementary School will neither create or aggravate racial imbalance.

A **RESOLUTION** of the Board of Directors of Seattle School District No. 1, King County, Seattle, Washington certifying that the Magnolia Elementary School Renovation and Addition project named in the project application (OSPI Form D-5) submitted to the Office of Superintendent of Public Instruction will not create or aggravate racial imbalance within the District boundaries.

WHEREAS, it has been determined that racial imbalance, as defined by WAC 392-342-025, does currently exist in the Magnolia<u>and</u>/-/West Queen Anne enrollment areas; and

WHEREAS, Catharine Blaine K-8 School, Lawton Elementary School and Coe Elementary School currently meet the definition of a racially imbalanced school as defined by WAC 392-342-025; and

WHEREAS, the proposed <u>construction</u> project <u>to is a</u> moderniz<u>e ation</u> and <u>construct an</u> addition <u>project of to</u> Magnolia Elementary School, a currently closed <u>school</u> site, to provide additional student capacity in the Magnolia/West Queen Anne enrollment area, <u>specifically and easeing</u> over-crowding at Catharine Blaine K-8 School, Lawton Elementary School and Coe Elementary School; and

WHEREAS, by re-drawing the boundaries for the Magnolia/West Queen Anne enrollment area to include <u>a the</u> re-opened Magnolia Elementary School, the enrollment at Magnolia Elementary School <u>will is projected to</u> be racially balanced <u>and</u>, the enrollment at Lawton Elementary School improves from racially imbalanced to balanced, <u>while and</u> the enrollment at Catharine Blaine K-8 School and Coe Elementary School remain racially imbalanced; and

WHEREAS, the proposed project at Magnolia Elementary School will not aggravate the existing racial imbalance in student enrollment in the Magnolia/West Queen Anne enrollment area as defined by WAC 392-342-025, but provides for two racially balanced schools where formerly none existed in the Magnolia/West Queen Anne enrollment area;

NOW THEREFORE, BE IT

RESOLVED, that the Seattle School Board of Directors certifies that the Magnolia Elementary School Renovation and Addition project will not create <u>or aggravatbuteand will</u> <u>minimizeminimize</u> racial imbalance within the District boundaries as defined for greater than fifty percent minority, non-multiracial school districts in WAC 392-342-025;

RESOLVED, that duly certified copies of this resolution shall be presented to Richard Best, Director, Capital Projects and Planning.





Magnolia and Surrounding ES Scenario B






