### 1. TITLE

Rainier Beach School Improvement Grant (SIG) Year 4 Funding

## 2. <u>PURPOSE</u>

This Board Action Report is to accept the School Improvement Grant totaling \$1,116,623 for the 2017-2018 school year at Rainier Beach High School.

#### 3. <u>RECOMMENDED MOTION</u>

I move that the School Board Authorize the Superintendent to accept the SIG year 4 funding for Rainier Beach High School.

### 4. <u>BACKGROUND INFORMATION</u>

- a. Background Rainier Beach High School applied for and received the School Improvement Grant Cohort III in April 2014. The grant period was from April 2014 to August 31, 2017. Year 4 funds are from a new grant that OSPI received from the US Department of Education in the Spring of 2017. Since the new grant award amount is consistent with previous grant amounts, OSPI was able to provide a slightly decreased level of funding to our SIG school for 2017-18. At this time we believe this is the final year of SIG grant funding for Cohort III. The grant's main purpose is to ensure equality in outcome for each student at Rainier Beach High School and raise on-time graduation rates from below 60%. Rainier Beach implemented the Transformation Modeling 2012 when the school applied for SIG Cohort II funding. The Transformational model focuses on transforming the school through developing and increasing teacher and school leader effectiveness; implementing comprehensive instructional reform strategies; increasing learning time and creating community-orientated schools; and providing operational flexibility and sustained support. The work of the grant is to be based in the 7 Principles of School Turnaround.
- b. **Alternatives** Not accept the funds. This is not recommended, as the funds will be used to continue the transformation of the systems at Rainier Beach High School.

c. **Research** Since 2012, Rainier Beach has seen an increase in the 4 year graduation rate from 53.7% for the class of 2011 to 81.5% for the Class of 2015.

On March 28th and 29th, I sat with a team from Rainier Beach High School and shared the Year 4 funding amounts based on the Office of System and School Improvement "not" receiving the full SIG Grant for the upcoming year (2017-18). This email is to inform you that in early July the Office of System and School Improvement received notification that Washington State "has received" the full allocated grant award of \$6.9 million dollars from the U.S. Department of Education.

#### What does this mean for SIG Schools?

The Office of System and School Improvement has reevaluated the previous award amounts shared with you. Please consider this email official notification to your **new** 2017-18 grant award.

#### In 2017-18, Rainier Beach High School will receive \$1,116,623.
