#### 1. TITLE

Building Excellence (BEX) V Capital Levy Program and Authorizing Resolution 2018/19-6

#### 2. PURPOSE

The current BEX IV Capital Levy will expire in calendar year 2019. The levy funds new construction, renovation, and additions to schools, safety and seismic improvements, building systems repairs, major preventive maintenance, technology, and other measures at schools throughout the district. The Six-year BEX V levy is proposed to be placed on the ballot on February 12, 2019.

#### 3. <u>RECOMMENDED MOTION</u>

I move the Board adopt Resolution 2018/19-6 placing a six-year capital levy on the February 12, 2019, Special Election Ballot for voter approval to fund the Building Excellence (BEX) V Capital Levy program.

#### 4. BACKGROUND INFORMATION

a. **Background.** The proposed BEX V Capital Levy replaces the expiring BEX IV Capital Levy. The proposal is for a single Capital Levy measure totaling \$1.4 billion over a sixyear term from 2020 - 2025.

Planning for the BEX V Capital Levy began in the Spring of 2016. In accordance with Board Policy 6901, Capital Levy Planning, the exploration of subsurface conditions and conceptual design concepts, focused on sixteen schools considered to be in the worst condition based on an independent, third party building condition assessment performed by Meng Analysis in 2014 and noted in the 2015 Facilities Master Plan Project Prioritization Update. In 2017, master plans were developed for an additional 12 schools based on analysis of the District's five-year enrollment projections, 10-year enrollment trends, and available capacity.

The BEX V Capital Levy proposal was developed and refined through nine Board work sessions from September 2017 through October 2018; regional community engagement meetings in April and September 2018; feedback from the BEX/BTA Capital Program Oversight Committee, the Facilities Master Plan Task Force, the Information Technology Advisory Committee (ITAC), and individual citizens. In addition, a Draft and Final

Environmental Impact Statement (FEIS) for the BEX V Capital Levy was developed, published and reviewed with the community. The FEIS was published on June 15, 2018, an appeal was filed and later dismissed following a hearing examiner's recommendation.

Approval by the voters would allow the collection of taxes over a six-year period to pay for construction measures to address facility concerns, capacity needs, building system repairs, and major preventive maintenance needs throughout the district. Projects funded by this levy would include the design and construction of educational facilities throughout the District, including: construction, renovation, or replacement of ten schools; seismic and safety improvements at six schools; building system repairs and replacements and major preventive maintenance projects at 72 schools; property acquisition; furniture procurement; installation of technology improvements district wide; and provide the necessary staffing to implement the identified projects. Additionally, within the BEX V levy proposed are other projects including, but not limited to, construction of school science labs and replacement of athletic fields and tracks. Transition planning, including the use of interim sites, were reviewed during levy planning to maximize the teaching and learning environment and minimize the impacts of construction on school communities.

Projects to be funded by the BEX V Capital Levy were selected following Board Policy 6901 Capital Levy Planning, and prioritized in accordance with the May 9, 2018, Board-Adopted Guiding Principles with an over-arching principle of racial and educational equity. Furthermore, the BEX V Capital Levy program and project details flow from the data and recommendations included in the Board-adopted 2018 Update to the Facilities Master Plan.

- b. **Alternatives** Do not approve Resolution 2018/19-6: This alternative is not recommended for the following reasons:
  - Without the projects funded by the BEX V Capital Levy, capacity shortfalls that
    are already significant in some schools/areas of the District will become a
    District-wide issue at all grade levels soon. With very limited General Fund
    support available for capital projects, the District would have to resort to noncapital actions (such as staggered sessions and converting remaining academic
    support spaces to General Education classrooms) to accommodate projected
    increases in enrollment.
  - Without the projects funded by the BEX V Capital Levy, building system conditions will continue to deteriorate and the current maintenance backlog will continue to increase.
- c. Research. Data and recommendations contained in the Board-adopted 2018 Update to the Facilities Master Plan are the basis for the project mix and specific project scopes included in the BEX V Capital Levy.

Following is a summary of the public process surrounding the development and refinement of the BEX V Capital Levy.

- Board work sessions: nine Board Work Sessions were held to develop and refine the BEX V Capital Levy: September 26 and December 13, 2017; March 28, May 1, May 30, June 25, August 22, September 26, and October 10, 2018.
- Ten community meetings were held across all regions of the District to share information and receive input and feedback from the public: April 2, 3, 23, 24, and 26, 2018; September 12, 13, 20, 24, and 25, 2018.
- Home language focus meetings were offered to multiple communities to discuss the levy preparations. Home language focus groups were held with Chinese and Somali communities.
- BEX/BTA Capital Programs Oversight Committee had numerous presentations concerning the progress and status of the BEX V Capital Levy.
- Information Technology Advisory Committee (ITAC) was established by the Board in April 2018 to serve as an advisory committee to provide ongoing expertise and community input for key technology initiatives and decisions. ITAC will be a standing committee of eighteen (18) members, including representatives from the community, employee groups and students.
- Facilities Master Plan Task Force was established by the Board in May 2018 to support the Board's oversight of capital planning by reviewing and validating the projected enrollment /capacity analysis and proposed scoring elements of the 2018 Facilities Master Plan Update. Task Force Members were selected based upon prior experience reviewing complex technical data and to provide a broad representation of communities throughout the city.
- The public continues to submit comments and questions regarding the Operation and Capital Levies via on-line surveys and emails.

#### 5. FISCAL IMPACT/REVENUE SOURCE

Fiscal impact to this action will be \$1.4 billion.

The revenue source for this motion is a six-year property tax levy that by this action will be placed before the voters in an election on February 12, 2019.

The district's goal is to ensure we have representative perspectives in all major decisions. The goal of Tier 2 engagement is to gather feedback on community values, initial staff recommendations, potential alternatives, and possible decisions. This approach ensures that the perspectives and concerns of the community are fully understood. Feedback from the various stakeholders was provided to the Board at multiple work sessions.

#### 7. EQUITY ANALYSIS

The district's Racial Equity Analysis toolkit was utilized to guide the planning process for the BEX V Capital Levy, influencing community engagement methods, preparation of the 2018 update to the Facilities Master Plan, and ultimately the final proposed levy package. The Board's guiding principles stated that racial and educational equity should be an overarching principle for the BEX V Capital Levy planning in accordance with Board Policy 0030, Ensuring Educational and Racial Equity.

The district's 2017-18 Equity Factor Tier Calculations – Deciles/Index information developed by the Research & Evaluation Department was used as part of the scoring and relative ranking of the proposed projects. The weighting of the criteria summary scores was determined by the Board, and the equity score was weighted more heavily than the other criteria summary scores resulting in a ranked proposed list of projects considered for the levy.

#### 8. <u>STUDENT BENEFIT</u>

The specific projects to be funded by the levy are in support of the District's Strategic Plan to ensure equitable access, close opportunity gaps and provide excellence in education for every student. The \$1.4 billion levy funds will fund the construction, remodeling, and modernization of the District's educational facilities in the following areas: replacing or modernizing buildings in poor condition, constructing additions to relieve overcrowding, building reinvestments, including roof replacements, mechanical system upgrades and interior and exterior renovations, life safety and Americans with Disabilities Act (ADA) compliance, acquisition of technology and technical infrastructure, and the construction and remodeling of academic facilities such as special education classrooms, high school science classrooms, and athletic fields.

Upon approval of this motion, the BEX V Capital Levy will be put before the voters in a special election on February 12, 2019. If the Levy is approved by voters, taxes will be levied for six years commencing in 2019 for collection in the calendar years from 2020 through 2025.

#### **RESOLUTION NO. 2018/19-6**

A RESOLUTION of the Board of Directors of Seattle School District No. 1, King County, Washington, providing for the submission to the qualified electors of the district at a special election to be held therein on February 12, 2019, of a proposition approving a program to levy additional taxes to provide a total of \$1.4 billion to fund the Building Excellence V Program for earthquake and other safety projects, to construct, renovate, replace or make additions to 10 schools, construction of building condition and infrastructure improvements and major preventive maintenance at 72 schools, acquisition and installation of technology improvements and other capital improvements throughout the district; to replace the expiring capital levy, such levies to be made for six years commencing in 2019 for collection in the calendar years from 2020 through 2025.

#### **RESOLUTION NO. 2018/19-6**

A RESOLUTION of the Board of Directors of Seattle School District No. 1, King County, Washington, providing for the submission to the qualified electors of the district at a special election to be held therein on February 12, 2019, of a proposition approving a program to levy additional taxes to provide a total of \$1.4 billion to fund the Building Excellence V Program for earthquake and other safety projects, to construct, renovate, replace or make additions to 10 schools, construction of building condition and infrastructure improvements and major preventive maintenance at 72 schools, acquisition and installation of technology improvements and other capital improvements throughout the district; to replace the expiring capital levy, such levies to be made for six years commencing in 2019 for collection in the calendar years from 2020 through 2025.

WHEREAS, the educational facilities of Seattle School District No. 1, King County, Washington (the "District") are in need of earthquake and other safety projects, increased capacity to meet enrollment growth, improvements in building condition for aging structures, technology improvements and major preventive maintenance throughout the district to meet the current and future educational needs of its students; and

WHEREAS, the Building Excellence Levy, Phase IV is expiring, and this levy will replace that levy; and

WHEREAS, projects funded by this levy would include earthquake and other safety projects in six schools, renovation, construction, replacement or additions to seven elementary schools, one middle school, one high school, and one interim school, construction of building condition and infrastructure improvements and major preventive maintenance at 72 schools, and acquisition and installation of technology equipment and implementation of training and other measures throughout the district; and

WHEREAS, funds available to the District will be insufficient to enable the District to implement such projects; and

WHEREAS, in order to support the cost of these projects as found necessary by the Board of Directors, it is deemed advisable that the District levy a tax upon all the taxable property within the District in excess of the annual tax the District is permitted by law to levy without a vote of the people, such levy to be made for six years commencing in 2019 for collection in the years 2020 through 2025, inclusive, as authorized by Article VII, Section 2 of the State Constitution and RCW 84.52.053; and

WHEREAS, the question of whether or not such excess tax may be levied must be submitted to the qualified electors of the District for their ratification or rejection; and

WHEREAS, the Board of Directors finds that preparation of a voters' pamphlet would inform and educate the voters regarding the proposition;

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF SEATTLE SCHOOL DISTRICT NO. 1, KING COUNTY, WASHINGTON as follows:

<u>Section 1.</u> <u>Finding</u>. It is hereby found and declared that the welfare of the students and other residents of the District requires the District to carry out the plans hereinafter provided.

Section 2. Authorization of Construction and Modernization Improvements. The District shall modernize and expand its school facilities throughout the District. These projects shall include such new schools, replacements, additions, modernizations, major maintenance, technology improvements and other capital expenditures as may be found necessary by the Board of Directors, including through the following programs:

- (1) Undertake earthquake and other safety projects at 6 schools.
- (2) Undertake school improvements including construction, renovation, rebuilding or additions at seven elementary schools, one middle school, one high school, and one interim school.

- (3) Undertake infrastructure improvements, and major preventative maintenance.
- (4) Acquisition and installation of technology equipment and implementation of training.

The District may repay any obligations hereafter incurred for the foregoing purposes.

If available funds are sufficient, the District shall acquire, construct, equip and make other capital improvements to the facilities of the District, all as the Board of Directors finds necessary; provided that such funds may be used only to support the construction, modernization, remodeling to school facilities or technology improvements and training.

If the District shall determine that it has become impracticable to accomplish any of such improvements or portions thereof by reason of changed conditions or needs, incompatible development, costs substantially in excess of those estimated, or acquisition by a superior governmental authority, the District shall not be required to accomplish such improvement and may apply levy proceeds as set forth in this section. If any or all of the improvements have been completed, or their completion duly provided for, or their completion found to be impractical, the District may apply the levy proceeds or any portion thereof to other portions of the improvements or to other capital purposes of the District, as the District in its discretion shall determine. Notwithstanding any other provision of this resolution to the contrary, levy proceeds may only be used to support the construction, modernization or remodeling of school facilities.

Section 3. Authorization of Levies. It is hereby found and declared that best interests of the District require the submission to the qualified electors of the District of the proposition whether the District shall make the Capital Projects Fund levies for their ratification or rejection at a special election to be held on February 12, 2019. For the purpose of providing funds necessary

for the needs described in Section 2 above, King County Elections, as *ex officio* supervisor of elections in King County, is hereby requested to call and conduct such special election to be held within the District on such day and to submit to the qualified electors of the District for their approval or rejection, a proposition providing for tax levies for the Capital Projects Fund for six years, commencing in 2019, producing dollar amounts at estimated tax rates per thousand dollars of assessed value to produce such amounts, in excess of the maximum amount tax levy permitted by law to be levied within the District without a vote of the electors, all as follows:

- A. \$233,333,333, said levy to be made in 2019 for collection in 2020;
- B. \$233,333,333, said levy to be made in 2020 for collection in 2021;
- C. \$233,333,333, said levy to be made in 2021 for collection in 2022;
- D. \$233,333,333, said levy to be made in 2022 for collection in 2023;
- E. \$233,333,334, said levy to be made in 2023 for collection in 2024; and
- F. \$233,333,334, said levy to be made in 2024 for collection in 2025.

The estimated levy rate depends upon the final dollar amount of assessed value of the property within the District. At this time, based upon information provided by the King County Assessor's office, the estimated levy rate for the 2019 levy is \$0.90 per thousand dollars of assessed valuation, the estimated levy rate for the 2020 levy is \$0.82 per thousand dollars of assessed valuation, the estimated levy rate for the 2021 levy is \$0.75 per thousand dollars of assessed valuation, the estimated levy rate for the 2022 levy is \$0.68 per thousand dollars of assessed valuation, the estimated levy rate for the 2023 levy is \$0.62 per thousand dollars of assessed valuation, and the estimated levy rate for the 2024 levy is \$0.56 per thousand dollars of assessed valuation. The exact levy rate shall be adjusted based upon the actual assessed value of the property within the District at the time of the levy.

Section 4. The Secretary of the Board of Directors is hereby authorized and directed to certify said proposition to the King County Elections, as ex-officio supervisor of elections in King County, substantially in the following form:

### **Process Overview**

The BEX V Capital Levy planning efforts began Spring 2016:

- Policy 6901 Capital Levy Planning guided process
- Efforts initially focused on developing Master Plans for 15 schools identified in poorest facilities condition in the 2015 Facilities Master Plan — Condition Projects;
- 12 additional schools added to develop Master Plans utilizing 2017 Enrollment Planning Department 5-Year Enrollment Projections — Capacity Projects.
- Building Systems Repairs & Replacements Projects identified utilizing the 2018 McKinstry Building Condition Assessment Survey and Facilities Department Personnel Assessment



### **Process Overview**

Proposed BEX V Capital Levy projects were further refined as a result of:

- Nine Board Work Sessions September 2017-October 2018;
- Ten Regional Community Engagement Meetings April and September 2018;
- Board Guiding Principles adopted May 2018
- Two Home Language Focus Groups in June 2018;
- Feedback from:
  - BEX/BTA Capital Program Oversight Committee,
  - Facilities Master Plan Task Force,
  - Information Technology Advisory Committee (ITAC)
- Feedback from individual citizens



# Capacity/Condition Project Scoring Overview

- Categories scored from the Board Policy 6901 and BEX V Adopted Guiding Principles:
  - (Equity) School Equity Tiers/Index
  - Health, Safety, and Security
  - Right Size Capacity
  - Building Condition
  - Educational Adequacy
- Scale of 1 to 5 for all categories
  - 1 = best condition; 5 = worst condition
- Equity analyzed utilizing Equity Index developed by Research & Evaluation Department based on Board and Community feedback
