#### 1. <u>TITLE</u>

For Action:

BTA IV: Award Contract K5077, Bid No. B11642, to Western Ventures Construction for the Garfield High School Roof Replacement project

#### 2. <u>PURPOSE</u>

This Board Action Report provides authorization for the Superintendent to enter into a construction contract for the roof replacement project at Garfield High School.

#### 3. <u>RECOMMENDED MOTION</u>

I move that the School Board authorize the Superintendent to execute construction contract K5077, Bid No. B11642, to Western Ventures Construction for the Garfield High School Roof Replacement project, in the amount of \$1,030,000, including Alternate No. 1, plus Washington State sales tax, in the form of the draft agreement attached to the Board Action Report, with any minor additions, deletions, and modifications deemed necessary by the Superintendent, and to take any necessary action to implement the contract.

#### 4. <u>BACKGROUND INFORMATION</u>

#### a. Background

The initial scope of work for this project included replacement and/or repairs to a portion of the existing roof at the site as described below. In addition, the selected architect and envelope consultant conducted further investigation to determine the extent of possible moisture intrusion pathways and detail needed repairs. During the course of their investigation, additional problems were identified and Capital Projects is recommending these be addressed as part of this contract to ensure all moisture intrusion problems are resolved.

At Garfield High School the Buildings, Technology and Academics (BTA) IV Capital levy included the replacement of the northern portion of the roof over the historic portion of the building. The investigation revealed numerous penetrations in the existing roof requiring infill and recommended replacement of the existing skylights. In addition, the Landmarks Board requested a non-typical fluid applied flashing membrane be utilized at the existing terra cotta cornice.

The most recent major project at Garfield was the Addition/Renovation in 2006 and the historic roof was not replaced.

The project was publicly bid March 29, 2017, with a total of four (4) bids being received. Western Ventures Construction was deemed to be the responsive low bid contractor, and the consulting firm S.M. Stemper Architects, recommends acceptance of the bid.

Ten (10) firms requested bid documents. A copy of the bid tab is attached.

#### b. Alternatives

If the contract is not awarded, the planned schedule for this capital construction project will not be maintained, and this work will not be performed, potentially leading to further damage and increased future repair costs as a result. Therefore, this alternative is not recommended.
