# 1. <u>TITLE</u>

BEX V, Distressed School Grant and K-3 Class Size Reduction Grant: Award Construction Contract P5149, for Bid No. B012049, to Allied Construction Associates, Inc. for the West Woodland Elementary Addition and Modernization project

# 2. <u>PURPOSE</u>

The purpose of this action is to:

- a. Provide authorization for the Superintendent to enter into a construction contract in the amount of \$14,536,000, plus Washington State Sales Tax, for the West Woodland Elementary Addition and Modernization project; and
- b. Approve transfer of \$1,700,000 from the BEX V Program Contingency funds to the West Woodland Elementary Addition and Modernization project.

# 3. <u>RECOMMENDED MOTION</u>

I move that the School Board:

- a. Authorize the Superintendent to execute construction contract P5149 with Allied Construction Associates, Inc. in the amount of \$14,536,000, plus Washington State Sales Tax, with any minor additions, deletions, and modifications deemed necessary by the Superintendent, and to take any necessary actions to implement the contract; and
- b. Approve a one-time fund transfer of \$1,700,000 from the BEX V Program Contingency funds to the West Woodland Elementary Addition and Modernization project.

# 4. <u>BACKGROUND INFORMATION</u>

#### a. Background

The West Woodland Elementary Addition and Modernization project, located at 5601 4<sup>th</sup> Avenue NW, Seattle, WA 98107, is funded through a Distressed Schools Grant program, BEX V Levy, and K-3 Class Size Reduction Grant. The project is scheduled to be completed by the start of the 2021-22 school year.

The West Woodland Elementary Addition and Modernization project was publicly bid on May 19, 2020, with a total of 6 bids being received. The scope of work for this project includes the construction of 12 new classrooms, an expanded gymnasium, commons, and associated support and infrastructure spaces. The remainder of the existing school building will receive interior finish upgrades and improvements to technology and communication infrastructure. The classroom and gymnasium addition will allow the existing seven on-site portables to be relocated and address projected student enrollment growth for the next decade. On March 2, 2020 the Operation Committee reviewed the West Woodland Design Presentation.

This motion allows the district to execute a construction contract with Allied Construction Associates, Inc., who was the lowest responsive, responsible bidder. The existing West Woodland Elementary school facility was built in 1990 by the Seattle architectural firm of Olson/Sundberg Architects.

Prior improvements made at West Woodland since 2000 include: wide area network in 2000; heat pump replacement in 2004; exterior renovations, interior, ADA, playground and library in 2010; green project – ground source heat pump phase II in 2013; and a new roof in 2014.

#### b. Alternatives

Deny Motion. If motion is denied, the district will not be able to execute the contract to start the construction of the West Woodland Elementary Addition and Modernization project. This is not recommended because it would negatively impact the district's commitment to provide equitable access in our schools.

# 5. <u>FISCAL IMPACT/REVENUE SOURCE</u>

The fiscal impact to this motion will be \$14,536,000, plus Washington State Sales Tax. The revenue source for this motion is from the State awarded Distressed Schools Grant program, BEX V Levy, and State awarded K-3 Class Size Reduction Grant. The total project budget, of which the construction contract is one part, is \$21,365,600.

The selection of projects in the BEX V program went through an extensive community vetting process and ultimately received 73% approval from voters in February 2019.

# 7. <u>EQUITY ANALYSIS</u>

The district's Racial Equity Analysis toolkit was utilized to guide the planning process for the BEX V Capital Levy, influencing community engagement methods, preparation of the 2018 update to the Facilities Master Plan, and ultimately the final proposed levy package. The Board's guiding principles stated that racial and educational equity should be an overarching principle for the BEX V Capital Levy planning in accordance with Board Policy No. 0030, Ensuring Educational and Racial Equity. Projects identified for inclusion in the BEX V levy will ultimately improve conditions for all students in the affected schools. Improved building conditions create a better environment for learning and can provide facilities to better position students for academic success.

It is the goal of the district to continue the process of implementing capital projects and provide students with safe and secure school buildings.
