1. TITLE

Amendment 1 to the BAR Adopting Resolution No. 2018/19-17 regarding Black Lives Matter at School Week

2. PURPOSE

This Board Action Report amends the aforementioned BAR to acknowledge that our commitment to underserved students includes students of all abilities.

3. RECOMMENDED MOTION

I move that Resolution No. 2018/19-17 be amended such that the third paragraph of the Resolution No. 2018/19-17 reads as follows:

"WHEREAS, as a public school district, we are facilitators of the limitless growth potential of human beings of all abilities, with a charge to guide our youth in finding and achieving their purpose with a belief that every human being deserves to live with dignity and to pursue their dreams; and"

4. <u>BACKGROUND INFORMATION</u>

- a. Background: Seattle Public Schools' black students are disproportionately identified for more intensive special education services, particularly for intellectual disabilities. Our black students with disabilities are disproportionately disciplined, as well as demonstrate unacceptable gaps in achievement. These are symptoms of unacceptable educational practices. Unless Seattle Public Schools fully recognizes and properly addresses the varying abilities of its students and how issues of ability intersect with race it will be unable to eliminate the opportunity gap and provide the high quality education our students deserve.
- b. **Alternatives:** Do not amend the Resolution. This is not recommended as it would miss the opportunity to highlight and address the various issues presented by the intersection of race and ability, and their impact on education.
