1. <u>TITLE</u>

Approving Board Policy No. 3242, Open/Closed Campus, and repealing Board Policy D42.00, Student Access and Egress.

2. <u>PURPOSE</u>

This action repeals an older policy about open and closed campuses and adopts a new one with clarifying language changes, but does not call for a change in current practice.

3. <u>RECOMMENDED MOTION</u>

I move that the School Board approve Board Policy No. 3242. Open/Closed Campus and repeal Board Policy D42.00, Student Access and Egress, as attached to the Board Action Report.

4. BACKGROUND INFORMATION

a. Background

Board Policy No. 3242, Open/Closed Campus, will replace Board Policy D42.00, Student Access and Egress. The new policy aligns with Washington State School Directors' Association WSSDA policies and is an accurate reflection of District practices. Board Policy D42.00 was last modified in November 1995. This policy update was on the calendar listing of Board Policies to be modified.

b. Alternatives

Do not repeal and replace Board Policy D42.00. This is not recommended because the policy does not provide sufficient clarity regarding high school students' ability to leave campus for meal periods.

c. Research

A survey was conducted to determine what the practice is at our comprehensive high schools with respect to open/closed campus for meal periods. See attached survey results.

Most of our equity analysis work around school lunch centers around students' time and space in the lunchroom and their ability to participate in the Free/Reduced Lunch program. While reviewing this policy, we are cognizant that all students are not able to eat off campus. There is no substantive change to this policy that would impact students' ability to participate in meal programs at school.

8. <u>STUDENT BENEFIT</u>

Amendment of the policy will provide greater clarity for students on their ability to come to and leave school grounds. This policy clarifies that students are to remain on campus during instructional hours and that the only deviation is for meal periods and as their individual school schedule dictates.
