#### 1. TITLE

BTA III: Award Architectural & Engineering Contract K1322 to S.M. Stemper Architects for the 2019 Roof Repair and Replacement projects

# 2. PURPOSE

The purpose of this action is to provide authorization for the Superintendent to enter into an Architectural & Engineering (A/E) contract in the amount of \$660,760 for the 2019 Roof Repair and Replacement projects.

# 3. RECOMMENDED MOTION

I move that the School Board authorize the Superintendent to execute contract K1322 with S.M. Stemper Architects in the amount of \$659,760, for architectural and engineering services for the 2019 Roof Repair and Replacement projects plus \$1,000 for Reimbursable Expenses, with any minor additions, deletions, and modifications deemed necessary by the Superintendent, and to take any necessary actions to implement the contract.

### 4. <u>BACKGROUND INFORMATION</u>

# a. Background

The 2019 Roof Repair and Replacement project consists of two programs: Cascade Parent Partnership Program located at North Queen Anne School building, 2919 1<sup>st</sup> Ave. W., Seattle, WA 98119, and Van Asselt Elementary School located at the African-American Academy building, 8311 Beacon Ave. S., Seattle, WA 98118. The projects are to be funded through the BTA III Levy passed by voters on February 9, 2010.

The scope of these two project sites will include but is not limited to:

# 1. Cascade Parent Partnership Program (North Queen Anne School building)

• Replace existing, failing, roof with a new roofing system; replace deteriorated structural components as necessary.

### 2. Van Asselt Elementary School (African-American Academy building)

• **Replace existing**, failing, roof with a new roofing system; replace deteriorated structural components as necessary.



The firm of S.M. Stemper Architects was selected through the Architectural and Engineering Services (A/E) selection procedures established in Superintendent Procedure 6220SP.C. Four firms submitted their qualifications. One firm was shortlisted and interviewed, and S.M. Stemper Architects was judged to be the most qualified to provide design services.

An interim contract (number K1326) was entered into to begin design services in the not-to-exceed amount of \$189,699, enabling project-specific work allowing completion of the overall project by summer 2019. The scope of work for the interim contract includes completion of schematic design and CAD-based plans at Cascade Parent Partnership Program at the North Queen Anne School building and Van Asselt Elementary School at the African American Academy building; this provides site investigations; and identifies scope of work.

In summary, the contract total for all A/E Services (including the Interim Contract K1326) for the 2019 Roof Repair and Replacement projects is \$850,459.

Prior improvements that have been made at North Queen Anne School since 2000 include: 2014
School Modernization to accommodate the Cascade Parent Partnership Program, formerly located at Wilson-Pacific, which was being displaced due to construction of the new Robert Eagle Staff
Middle School/Licton Springs K-8 School and new Cascadia Elementary School. The roof was identified at that time as needing replacement, but funding to implement the replacement had not been identified.

There have been minimal facility improvements at the African-American Academy as the school was constructed in 2000/2001 time-frame and opened Fall 2001.

#### a. Alternatives

Deny Motion. If the motion is denied, the district will not be able to execute the contract to start the design of the 2019 Roof Repair and Replacement School projects. Therefore, the planned schedule for this project will not be maintained; there may also be future loss of use should associated damages occur due to these areas already experiencing damage not having been repaired/replaced. This is not recommended.

# b. Research

The architect will employ the following resources when planning and beginning design of these projects:

- Meng Facilities Condition Assessment Report, 2009; updated 2014
- "Roofing & Cladding Surveys" dated April 30, 2018, North Queen Anne School, prepared by S.M. Stemper Architects/Building Envelope Technology & Research (BET & R)
- S.M. Stemper Architects' Pre-design Estimate, dated August 8, 2018, for Roof Replacement at the African American Academy at Van Asselt Elementary School
- Seattle Public Schools Technical Building Standards dated December 2012

#### 5. FISCAL IMPACT/REVENUE SOURCE

The fiscal impact of this motion to approve contract K1322 will be \$660,760, including Reimbursable Expenses. The revenue source for this motion is 100% BTA III Capital levy funds.

As noted above, due to schedule constraints, interim contract number K1326 was executed previously to authorize the Architect to complete the schematic design phase at Cascade Parent Partnership Program at North Queen Anne and at Van Asselt Elementary School at the African American Academy to provide site analysis and identify the scope of work recommendations.

The amount of the interim contract is \$183,005; plus estimated Reimbursable Expenses of \$6,694.00 (totaling \$189,699). In summary, the contract total for all A/E Services (including the Interim Contract K1326) for the 2019 Roof Repair and Replacement projects is \$850,459.

Contract award to implement construction activities will be funded with the successful passage of BEX V.
