1. TITLE

BTA III & BTA IV: Final Acceptance of Public Works Contract K5076 with Sprinturf LLC, for the Synthetic Turf Replacement at Old Van Asselt and Whitman Middle School and Field Lighting Infrastructure at Whitman Middle School project

2. PURPOSE

This action approves the final acceptance of Public Works Contract K5076 with Sprinturf LLC, for the Synthetic Turf Replacement at Old Van Asselt and Whitman Middle School and Field Lighting Infrastructure at Whitman Middle School project. Board approval allows the district to submit required documents to the State of Washington: Department of Labor & Industries, Department of Revenue, and the Employment Security Department in order to proceed with project closeout.

3. RECOMMENDED MOTION

I move that the School Board accept the work performed under the BTA III & BTA IV funded Public Works Contract K5076, with Sprinturf LLC, for the Synthetic Turf Replacement at Old Van Asselt and Whitman Middle School and Field Lighting Infrastructure at Whitman Middle School project, as final.

4. BACKGROUND INFORMATION

a. Background

The improvements for this project included replacing the existing synthetic turf at the athletic fields at Old Van Asselt, located on 7201 Beacon Ave. S., Seattle, WA 98108, and Whitman Middle School, 9201-15th Avenue NWBeacon Avenue South, Seattle, WA 98117, which were originally installed in 2006. The work was required as part of the turf replacement cycle by the district and included in the BTA III levy. Additionally, civil and electrical infrastructure work was performed at Whitman Middle School from BTA IV funds for future athletic field lighting. Re- surfacing of the existing jogging track at Old Van Asselt and other associated field improvements at both Old Van Asselt and Whitman Middle School were also completed. The project budget was\$3,444,061. The architect for the project has recommended that the project be accepted as complete. The contractor has satisfactorily completed the contract work and the consulting architect agrees and recommends final acceptance of the project.

During the course of the project, one (1) Change Order was issued which totaled a credit of \$4,142. Costs of relocation of a future light pole were offset by a reduction of scope revising field markings and removal of test equipment from the contract. The change order costs were reviewed as reasonable and accepted.
