General Fund

For December 2020, the ending fund balance is \$145.0M. This compares to \$142.1M for December 2019. December enrollment of 51,438 is less than adopted budget for 2020-2021 by 1,865 FTE. Revenues are \$305.8 YTD, compared to \$301.9M last year (see Pg. 4). While revenues appear to be higher in December, adjustments to revenue will be seen with our January apportionment due to decreased enrollment. Expenditures of \$309.6M are up\$7.7M over the previous year (see Pg. 4).

Capital Projects Fund

The Capital Projects Fund balance is \$203.6M compared to \$79.5M in the prior year. Fund balance is comprised primarily of BEX IV \$57.7M, BTA III \$18.6M, BTA IV \$(63.0)M, BEX V \$166.8M, and Other Programs \$21.0M. Revenues are \$145.8M, consisting primarily of property taxes earnings from the BEX V \$106.9M and BTA IV levy \$36.5M. Expenditures of \$46.5M are comprised principally of BTA IV \$10.4M and BEX V \$29.0M (see Pg. 10).

Debt Service Fund

At December 2020, the fund balance is \$1.39M. Fund balance is restricted for payments of the principal and interest related to the 2020 refunding bond. (see Pg. 13).

Associated Student Body

The Associated Student Body Funds represent monies raised by student groups for cultural, athletic, recreational, and/or social purposes. Fund balance at December 2020 is \$3.6M compared to \$4.1M last year (see Pg. 11). YTD Revenue is \$222K, and Expenditures are \$145K. Activity in this fund is down due to COVID-19.

Private/Trust

The Trust Fund accounts are monies donated to the District for private purposes, primarily scholarships, and are governed by individual agreements. Fund balance at December 2020 is \$2.4M compared to \$2.4M as of December 2019.

Investments

The King County Pool net earned interest rate was .79% in December, compared to 2.26% of the previous year (see Pg. 9). The rate is decreasing since the last year, due to economic downturn related to COVID-19.

Seattle School District Average Annual Enrollment by Grade As of 12/31/2020

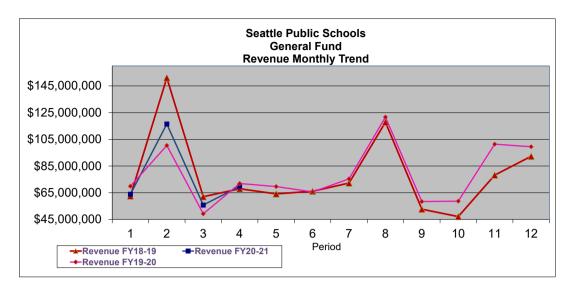

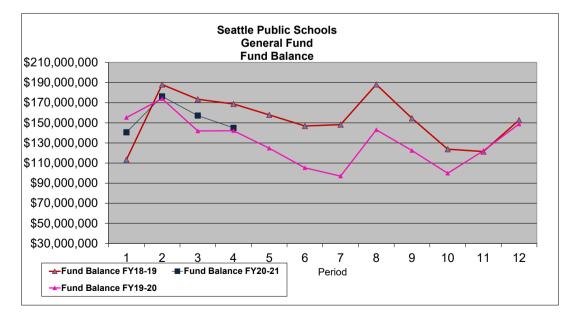
