## **1. TITLE**

Adopting Board Resolution 2016/17-13, Fully Funding Basic Education

**For Introduction:** February 15, 2017  
**For Action:** March 1, 2017

## **2. PURPOSE**

This motion would adopt a Board Resolution regarding the need to fully fund basic education, including delaying the levy cliff.

## **3. RECOMMENDED MOTION**

I move that the School Board adopt Resolution 2016/17-13, as attached to the Board Action Report.

## **4. BACKGROUND INFORMATION**

- a. **Background:** Washington State’s Constitution states that amply funding education is the State’s paramount duty. In 2012, the Washington Supreme Court found the State has failed in its constitutional obligations to fully fund basic education. In addition, the state has created a manufactured crisis by reducing districts’ school levies by approximately \$500 million, but without fully funding education. As a result, the district is preparing to make devastating cuts to staff and services to students. This resolution calls on the state legislature to fully fund education and delay the levy cliff until that funding is fully implemented.
- b. **Alternatives:** Not adopt a resolution. This is not recommended as the district’s voice needs to be heard regarding the needlessly devastating cuts for which the district is preparing.
- c. **Research:** Washington is 43<sup>rd</sup> in the nation in state funding for K-12 education.

Fiscal impact to this action will be N/A. While adopting this resolution does not have a fiscal impact on the district, the purpose of the resolution is to encourage the legislature to fully fund basic education.

**Resolution No. 2016/17-13**



**A RESOLUTION** of the Board of Directors of Seattle School District No. 1, King County, Seattle, Washington, urging the Washington State Legislature to take immediate action to provide full funding for basic education.

**WHEREAS**, Washington’s Constitution says that ample funding for education is the State’s only paramount duty; and

**WHEREAS**, Washington is 43<sup>rd</sup> in the nation in state funding for K-12 education; and

**WHEREAS**, the Washington State Legislature defined basic education in 2009 and 2010; and

**WHEREAS**, in 2012 the Washington Supreme Court found the State to have failed in their constitutional obligations to fully fund basic education, including steady and consistent progress to fully fund compensation obligations; and

**WHEREAS**, the State has created a manufactured crisis by reducing districts’ school levies by approximately \$500M but without fully funding education;

**NOW THEREFORE, BE IT RESOLVED**, that the Seattle School Board calls for immediate action by the Legislature to do no harm by fully funding state obligations to provide ample and equitable education for all students and allow school districts to utilize levies for local needs.
