1. TITLE

BEX IV: Award Construction Contract P5099 to CDK Construction Services, Inc., for the Eckstein Middle School Seismic Improvements project

2. <u>PURPOSE</u>

The purpose of this action is to provide authorization for the Superintendent to enter into a construction contract for the Eckstein Middle School Seismic Improvements project.

3. RECOMMENDED MOTION

I move that the School Board authorize the Superintendent to execute construction contract P5099 to CDK Construction Services, Inc., for the Eckstein Middle School Seismic Improvements project, in the amount of \$2,917,672, including Alternate Nos.1 & 2, plus Washington State sales tax, with any minor additions, deletions, and modifications deemed necessary by the Superintendent, and to take any necessary action to implement the contract.

4. <u>BACKGROUND INFORMATION</u>

a. Background

The Eckstein Middle School Seismic Improvements project is funded through the BEX IV Capital Levy passed by the voters in February 2013.

The project scope includes seismic improvements at various parts of the school; including installation of new plywood and concrete shear walls, and lowering of two exterior unreinforced masonry chimneys. The improvements will provide a safer building during future seismic events. Additionally, ADA (Americans with Disabilities Act) accessibility improvements will be made as part of the seismic work and to meet the current Seattle Building Code. Improvements will include compliant drinking fountains, installation of a wheel chair lift, and converting staff toilet rooms for better accessibility.

The project was publicly bid on March 22, 2018, with two bids being received. The Base Bid is \$2,817,872 plus Washington State sales tax. Accepting Alternate Bids 1 and 2 will result in a construction contract award amount of \$2,917,672 plus Washington State sales tax. CDK Construction Services, Inc, was deemed to be the low bid contractor, and the

consulting firm Rolluda Architects recommends acceptance of the Total Bid amount including Alternate Bids 1 and 2 which add seismic work in two additional rooms.

From 1982-2017, additional construction renovation history at Eckstein Middle School includes numerous upgrades ranging from a fire alarm project to roofing, seismic, mechanical, electrical, technology, science classroom, ADA (Americans with Disabilities), athletic field, and exterior and interior finishes upgrades.

Seismic upgrades were last completed in 2005 and 2015.

b. Alternatives

Deny Motion. If motion is denied, the district will not be able to execute the contract to start construction on the Eckstein Middle School Seismic Improvements project.

The selection of projects in the BEX IV program went through an extensive community vetting process and ultimately received 72.1% approval on February 12, 2013.
