#### 1. TITLE

Approval of Attendance Area Boundary Changes for Robert Eagle Staff Middle School and Jane Addams Middle School for 2019-20.

#### 2. PURPOSE

This Board Action Report outlines middle school attendance area boundary changes beginning in 2019-20 due to (a) enrollment overcapacity at Robert Eagle Staff Middle School and (b) Olympic View community requests to move to the Jane Addams attendance area.

#### 3. RECOMMENDED MOTION

I move that the School Board approve the middle school attendance area boundary changes as outlined in Attachment A, and grandfather assignments for currently enrolled students impacted by these changes. Additionally, I move that the Board direct the Superintendent to take any appropriate action to implement this decision.

#### 4. BACKGROUND INFORMATION

a. **Background:** When Robert Eagle Staff Middle School opened in Fall 2017, the Olympic View Elementary School attendance area feeder pattern was split between Jane Addams Middle School and Robert Eagle Staff Middle School. Areas 91 and 92 are the parts of the Olympic View Elementary School that feed to Robert Eagle Staff Middle School. Since the decision, many families from areas 91 and 92 have expressed that they would prefer to be in the Jane Addams attendance area.

Enrollment at Robert Eagle Staff Middle School and Licton Springs K-8 exceeds capacity at the Robert Eagle Staff and Licton Springs K-8 campus. In October 2018, Robert Eagle Staff Middle School had 838 enrolled students and Licton Springs K-8 had 175 enrolled students for a total site enrollment of 1,013. The site was built to accommodate 1,000 middle school students, but because of space sharing and elementary class size reductions, actual right size capacity is 912.

b. **Alternatives** Three additional scenarios were considered to address capacity problems at the Robert Eagle Staff and Licton Springs K-8 campus. The four scenarios were

presented to community members at a community meeting at Robert Eagle Staff on November 7, 2018. Community feedback for the alternatives was overwhelmingly negative while feedback for the Olympic View feeder change was almost entirely positive. The Olympic View feeder change does not fully address capacity problems at Robert Eagle Staff Middle School. Work to address overcrowding at Robert Eagle Staff Middle School and Licton Springs K-8 will continue next year.

If this portion of Olympic View stayed in The Robert Eagle Staff attendance area, Olympic View families would continue to be split between Jane Addams and Robert Eagle Staff at middle school, then the same families would be assigned to Nathan Hale with their elementary peers again. Robert Eagle Staff would remain overcrowded and would need another portable. The change proposed in this BAR increases enrollment at Jane Addams Middle School which is over its right size capacity, but not as significantly as Robert Eagle Staff.

#### 5. FISCAL IMPACT/REVENUE SOURCE

Tier 3: Collaborate

This boundary change will help alleviate capacity pressure at Robert Eagle Staff Middle School and may reduce the need for additional portables on site.

The students from the Olympic View attendance area can be accommodated by existing bus service at Jane Addams Middle School, so no additional buses are needed.

Since 2017, families in the Olympic View Elementary School attendance area who are assigned to Robert Eagle Staff Middle School have expressed their preference to be assigned to Jane Addams Middle School. This scenario was included in options for reducing enrollment at Robert Eagle Staff Middle School because of community input.

On November 7, 2018, Seattle Public Schools hosted a community meeting with Robert Eagle Staff Middle School and Licton Springs K-8 to discuss scenarios for reducing enrollment. Families from change areas 91 and 92 attended to support the boundary change and express preference for grandfathering for currently enrolled students. Almost all the comments and emails received have been in support of the boundary change with grandfathering for currently enrolled students.

### 7. <u>EQUITY ANALYSIS</u>

District staff reviewed the demographic characteristics of students impacted by potential changes. Attachment C in the appendix shows the characteristics of impacted 6-8 residents as well as the characteristics of Robert Eagle Staff Middle School (current attendance area school) and Jane Addams Middle School (proposed attendance area school). The impacted students do not have a disproportionate number of historically underserved students. Additionally, the change does not significantly impact the demographics of Robert Eagle Staff Middle School or Jane Addams. See Attachment C for Robert Eagle Staff Middle School and Jane Addams Middle School demographics.

#### 8. STUDENT BENEFIT

This action will help to reduce overcrowding that currently exists at the building housing Robert Eagle Staff Middle School and Licton Springs K-8. Additionally, this action will allow students in areas 91 and 92 to attend school with their elementary school classmates and attend school without crossing I-5. Families expressed strong preference for this action.

#### 10. POLICY IMPLICATION

Board Policy No. 3130, Student Assignment, states that students shall have the opportunity to attend an elementary, middle or high school in a designated attendance area based upon home address, unless the school designated by a student's home address does not have the appropriate services for the students' needs, as determined by the District. Any changes to boundaries, geographic zones, or assignment rules subsequent to implementation of the Student Assignment Plan require Board action.


#### 11. BOARD COMMITTEE RECOMMENDATION

This motion was discussed at the Operations Committee meeting on December 6, 2018. The Committee reviewed the motion and recommended bringing the boundary change to the full Board for consideration on January 9, 2018.

Upon approval of this motion, the attached middle school attendance area boundaries will be implemented, beginning in the 2019-20 school year. The Student Assignment Transition Plan will be updated to reflect these changes.

#### **Change Area**

There are 91 grade 6-8 residents in change areas 91 and 92. Only 43 of those residents attend Robert Eagle Staff Middle School, 12 attend Jane Addams Middle School, and the rest attend other attendance area middle schools or option schools.
