1. TITLE

Approval of Interlocal Agreement with State of Washington, Department of Enterprise Services, for the design and construction of 4 classrooms using cross laminated timber at Maple Elementary School For Introduction: January 4, 2017
For Action: January 18, 2017

2. <u>PURPOSE</u>

The Board Action executes an Interlocal Agreement with State of Washington, Department of Enterprise Services (DES), for the design and construction of a 4 classroom addition at Maple Elementary School using cross laminated timber. Funding for the project is being provided by the Washington State Legislature through a budget proviso and is part of the state's obligation to fund public education for Washington students. The value of this work is approximately one million dollars.

3. <u>RECOMMENDED MOTION</u>

I move that the School Board authorize the Superintendent to execute an Interlocal Agreement with State of Washington, Department of Enterprise Services in the form of the draft Agreement attached to the Board Action Report, with any minor additions, deletions, and modifications deemed necessary by the Superintendent, and to take any necessary actions to implement the agreement.

4. <u>BACKGROUND INFORMATION</u>

- a. **Background:** Pursuant to 2015 3rd Legislative Sp.S. Budget Proviso in Chapter 3 Sec. 1022. The State of Washington has proposed to build classrooms at multiple School Districts. Six School Districts were selected, including Seattle Public Schools, for the design and construction of a school addition using a process known as cross laminated timber. The Districts agree to accept the additional classrooms on their property. The State selected the team of Walsh Construction and Mahlum Architects to design, manage and build all projects. The Maple Elementary project for Seattle Public Schools will be completed and ready for use by the Fall of 2017.
- b. **Alternatives:** Do not execute the agreement Interlocal Agreement with State of Washington, Department of Enterprise Services, and <u>not</u> construct the four classroom addition at Maple Elementary School. District could provide 4 conventional portables at cost in excess of \$640,000 from our Capital Funding.

c.	Research : The District is familiar with the Architect in that they are currently involved
	with several Seattle School District projects. The design will endeavor to follow both the
	District's Education Specifications and Technical Specifications.

5. <u>FISCAL IMPACT/REVENUE SOURCE</u>

Fiscal impact to this action will be the purchase of furnishings and maintenance of operating costs of new facilities. In as much as, Maple Elementary would require additional capacity in the future, the Capital avoidance benefit to the District is about one million dollars.
