1. TITLE

BTA III: Award Construction Contract K5080, Bid No.
B11637 to Mike Werlech Construction, Inc. for the
Blaine Water Mains and Fire Sprinklers Project

For Introduction: March 1, 2017

For Action: March 15, 2017

2. PURPOSE

This Board Action Report provides authorization for the Superintendent to enter into a construction contract for the installation of new water mains and the addition of fire sprinklers at Catharine Blaine K-8 School during the summer of 2017.

3. RECOMMENDED MOTION

I move that the School Board authorize the Superintendent to execute construction contract K5080, to Mike Werlech Construction, Inc. for the Blaine Water Mains and Fire Sprinklers Project, in the amount of \$949,822, including Alternate Bid 1, plus Washington State sales tax, in the form of the draft agreement attached to the Board Action Report, with any minor additions, deletions, and modifications deemed necessary by the Superintendent, and to take any necessary action to implement the contract.

4. <u>BACKGROUND INFORMATION</u>

a. Background

Prior to the 2010 Buildings, Technology, and Academics (BTA III) capital levy, public community meetings were held at various locations within the district. Informational brochures were distributed identifying what projects would be performed at each school, and public comment was received. Catharine Blaine K-8 School Water Mains and Fire Sprinkler Installation project originated from the Meng Building Conditions Report issued May 2009, and was included on the BTA III capital levy. To accommodate school programs and complete the work in the summer months, the fire suppression system for the school building is scheduled to be completed in the summer of 2017.

The project was publicly bid February 14, 2017, with a total number of two (2) bids being received. Mike Werlech Construction, Inc. was deemed to be the low bid contractor, and the consulting firm Hultz BHU Engineers recommends acceptance of the bid. Upon acceptance of Alternate Bid 1, the project will provide fire sprinklers in the gym complex. Seven (7) firms requested bid documents. A copy of the bid tab is attached.

b. Alternatives

If the contract is not awarded, the planned schedule for this capital construction project will not be maintained, and this important life safety system will not be installed. Therefore, this alternative is not recommended.

In February 2010, the six-year \$270M Capital levy, Buildings, Technology and Academics III, (BTA III), was approved by Seattle voters. It was a renewal of the Buildings, Technology and Academics II (BTA II) levy, passed by Seattle voters in February 2004. The selection of projects in the BTA program was designed to provide equitable access to schools across the district.

This action will benefit students by providing an important fire and life safety system to protect the students, and safeguard the building and contents in the event of a fire within the building.
