1. TITLE

BEX V: Award Architectural & Engineering Contract P1634 to Stemper AC for the West Seattle High School Roof Replacement project

2. PURPOSE

The purpose of this action is to provide authorization for the Superintendent to enter into an Architectural & Engineering (A/E) contract in the amount of \$676,377 for the West Seattle High School Roof Replacement project.

3. <u>RECOMMENDED MOTION</u>

I move that the School Board authorize the Superintendent to execute A/E contract P1634 with Stemper AC in the amount of \$676,377, for architectural and engineering services for the West Seattle High School Roof Replacement project, with any minor additions, deletions, and modifications deemed necessary by the Superintendent, and to take any necessary actions to implement the contract.

4. BACKGROUND INFORMATION

a. Background

The West Seattle High School Roof Replacement project, located at 3000 California Avenue SW, Seattle, WA, 98116, is funded through the BEX V/Building for Learning levy passed by the voters in February 2019.

The project scope addresses the portion of West Seattle High School built as new construction in 2002 and includes the replacement of the existing low-slope thermal polyolefin (TPO) roofing system with a new 3-ply APP polymer-modified bituminous low-slope roofing system. This project was identified when the 2017 historic clay tile, partial roof replacement project was completed. The TPO roofing system was identified to be in poor condition at that time and subsequently earmarked for replacement as part of the BEX V scope of work. The roofing lifespan of TPO roofs is fifteen years from the time of installation. SPS' technical standards now require a 3-ply APP polymer-modified bituminous low-slope roofing system which has a substantially increased life expectancy that is at least double that of the roof currently installed at West Seattle High School.

The firm of Stemper AC was selected through the Architecture and Engineering (A/E) selection procedures established in Superintendent Procedure 6220SP.C. Six (6) firms submitted their qualifications and three (3) firms were shortlisted and interviewed. Stemper AC was judged to be the most qualified to provide the design services for this project.

Prior improvements made at West Seattle High School since the year 2000, include: a building-wide modernization 2002; gym lighting improvements 2011; and, historic clay tile, partial roof replacement 2017.

a. Alternatives

Deny Motion. If motion is denied, the district will not be able to execute the contract to start the design of the West Seattle High School Roof Replacement project. The existing TPO roof is in poor condition, increasing the risk of moisture intrusion and related consequential damages.
