## 1. <u>TITLE</u>

Special Education Contract Amendments.

## 2. <u>PURPOSE</u>

This Board Action Report details contract amendments for community agencies, non-public agency schools, and contractors serving students with disabilities.

The following contracts in special education need to be amended: Children's Institute for Learning Differences (CHILD); Maxim Healthcare Services; Overlake Specialty School; Yellow Wood Academy; and Boyer Children's Clinic.

## 3. <u>RECOMMENDED MOTION</u>

I move that the School Board authorize the Superintendent to approve contract amendments in an amount totaling \$1,254,933.34 for the above-listed agencies and contractors.

# 4. BACKGROUND INFORMATION

**Background** - These contracts are over the amount previously approved by the Board due to the number of additional students who were added to each contract's rosters for required services for the 2019-20 school year. This motion is to request retroactive approval for the unanticipated increases to each of these provider contracts.

Children's Institute for Learning Differences (CHILD); Maxim Healthcare Services; Overlake Specialty School; Yellow Wood Academy - There are Seattle Public Schools students with Individualized Education Programs (IEPs) that require highly specialized special education services that the district is unable to provide due to the appropriate, specialized placements for these services. These services may include individual tutoring or instruction and individual behavioral or social emotional learning instruction. The identified agencies agreed to accept these students or provide these specialized, IEP-driven services. The contract amendments are needed for these nonpublic agencies have occurred because additional students were added to their rosters through the IEP process.

In addition, Boyer Children's Services provides special education services under Part C of the IDEA to children ages birth to three. State law requires SPS to pass through all amounts received for Part C services. The Basic Educational Allocation (BEA) rate was increased late in the school year by OSPI. This caused the original contracted amounted to be exceeded and an amendment is now needed.

a. Alternatives Not to approve this motion. This is not recommended because the students' legally mandated Individualized Education Programs (IEPs) and evaluative service needs will not be met. SPS would not meet state law if the pass-through amount was provided to Boyer.

# 6. <u>COMMUNITY ENGAGEMENT</u>

Community engagement for the original contracts was elicited through the RFQ process for RFQ 02758, Specially Designed Instruction: Individual Education Program (IEP) Based Tutoring Services and other Compensatory Education Services, for students who require these services as identified in their IEP or by district processes. Through the RFQ process, feedback and responses to questions were elicited from respondent agencies. The SPS Behavior and Autism Intervention Team (BAIT) has also been involved and advised in support of students and the identification of needs. We collaborate with families whose students are receiving services from these providers.

# 7. <u>EQUITY ANALYSIS</u>

Utilizing the District Equity Analysis tool process, the demographics of the students who are receiving services through the RFQ for the original contracts were reviewed, understanding that the total population is small. IEP teams have made highly specialized recommendations for these students based on their individualized needs, which includes parents/guardians. Additions to the contracts were based on IEP team decisions.

# 8. <u>STUDENT BENEFIT</u>

All students placed by the district and served by Yellow Wood, Overlake Specialty School, and Maxim are IDEA protected students in receipt of special education services with active IEPs. Students served at Boyer Clinic are qualified for early intervention services under Part C of the IDEA.
