1. TITLE

Recommendation to Extend Contract Terms and Amend Contract Amounts for Furniture Procurement for 2021-2022, Bid No. B05866

2. PURPOSE

Per Board Policy No. 6220, Procurement, all contracts exceeding \$250,000 must be approved by the Board. Public Works Contracts for the Furniture Procurement for 2021-2022 exceed \$250,000.

3. RECOMMENDED MOTION

I move that the School Board authorize the Superintendent to execute the contract amendments that extend current contracts approved by the board on March 11, 2020, and amend the contract amounts for an additional year for Furniture Procurement for 2021-2022 with the following three vendors:

- Catalyst Workplace Activation Inc., a one-year amendment to contract #P5118 (Bid No. B05866) with an increase of \$1,541,836.20 to the current contract amount of \$6,500,858.77 for a revised contract total not to exceed \$8,042,694.97
- Evergreen Furnishings LLC, a one-year amendment to contract #P5119 (Bid No. B05866) with an increase of \$5,000.00 to the current contract amount of \$369,850.00 for a revised contract total in the amount not to exceed \$374,850.00
- Saxton Bradley Inc, a one-year amendment to contract #P5120 (Bid No. B05866) with an increase of \$91,930.00 to the current contract amount of \$235,585.00 for a revised contract total in the amount not to exceed \$327,515.00;

plus Washington State sales tax, with any minor additions, deletions, modifications, and actions deemed necessary to implement the contracts.

4. <u>BACKGROUND INFORMATION</u>

a. Background

As part of the capital improvement projects, furniture will be required. These contracts are part of the district furniture procurement plan and establish a competitively bid furniture catalog from which Capital Projects and schools can order furniture. The district is not

required to pay the amount listed in each contract but may purchase furniture up to that contract amount.

The project, Furniture Procurement 2019-2020, was publicly advertised on May 24, 2018. The bid opened July 10, 2018, with a total of five bids being received. Based on the final evaluation, three contracts were awarded, two of which were more than \$250,000. Board Action Approval occurred on September 5, 2018. Initial contract terms were effective as of October 1, 2018 through March 31, 2020. A one-year contract amendment extended the contract terms through March 31, 2021. Board Action Approval occurred on March 11, 2020.

The contract renewal option was stated in the contract term of the bid. This one-year term extends the contract terms and amends contract amounts for furniture procurement April 1, 2021 through March 31, 2022.

The contracts being extended will be in effect for this additional year.

Catalyst Workplace Activation Inc has a contract #P5118 (Bid No. B05866) that expires March 31, 2021, in the amount of \$6,500,858.77. A one-year extension of the contract for the 2021-2022 amendment increase is \$1,541,836.20. Revised total for P5118 contract amount is not to exceed \$8,042,694.97.

Evergreen Furnishings LLC has a contract #P5119 (Bid No. B05866) that expires March 31, 2021, in the amount of \$369,850. A one-year extension of the contract for 2021-2022 amendment increase is \$5,000. Revised total for P5119 contract amount is not to exceed \$374,850.

Saxton Bradley Inc has a contract #P5120 (Bid No. B05866) that expires March 31, 2021, in the amount of \$235,585. A one-year extension of the contract for 2021-2022 amendment increase is \$91,930. Revised total for P5120 contract amount is not to exceed \$327,515.

b. Alternatives

Do not approve the motion. This is not recommended. If the contracts are not awarded, multiple Capital Projects' schedules could be delayed because they won't have the necessary furniture procured on a per-project basis.

These contracts will extend the purchasing agreement for a period of one year to purchase furniture for both BTA and BEX Capital Levy Projects, in addition to other school needs. Purchases will be made primarily from various capital budgets. These purchasing agreements also support other school or district purchasing needs from other various budgets.
