### 1. <u>TITLE</u>

Amendment 3 to the Student Assignment Plan for 2017-For I18: Remove HCC geo-split to Decatur and move entireFor Acohort to new Cascadia siteFor A

For Introduction:December 7, 2016For Action:January 4, 2017

# 2. <u>PURPOSE</u>

The proposed Student Assignment Plan contains provisions to create a new Highly Capable Cohort (HCC) site at the Decatur building to alleviate pressure from recent growth in the HCC program. Given the short timeline and uncertain budget environment for 2017, this amendment is being proposed to delay implementation, and reconsider for Fall of 2018 to allow sufficient time and budget to establish this new school.

District staff have not had time to review this amendment before posting on December 7, 2016.

### 3. <u>RECOMMENDED MOTION</u>

I move that the School Board amend the proposed Student Assignment Plan for 2017-18 to move the existing HCC students from the interim site at Lincoln to the new Cascadia building on the Wilson Pacific Campus, including:

- Transfer of surplus portables to the site as needed to manage short-term capacity
- Reconsideration of the Decatur site for HCC split for Fall of 2018

- Completion of any/all work on the Decatur building/site prior to 2018 start of school; and editing language in the Assignment Plan as shown in the amendment attached to this Board Action Report [to be added subsequent to the Dec. 7 meeting].

### 4. BACKGROUND INFORMATION

#### a. Background

The proposed Student Assignment Plan incorporates a new HCC pathway site at the Decatur building. More information in this section will be added after the Dec. 7 meeting.

#### b. Alternatives

Proceed with the current plan to create a new HCC school site at Decatur. This is not recommended as the timing is quite short to identify and hire a planning principal and establish this school. Additionally, the budget deficit identified for 2017 could impact the ability to implement and support this new school.
