1. <u>TITLE</u>

BTA IV: Award Contract K5088 to Wayne's Roofing, Inc. for the Ballard and West Seattle High Schools Roof Replacement project

2. <u>PURPOSE</u>

This Board Action Report provides authorization for the Superintendent to enter into a construction contract for the roof replacement project at Ballard and West Seattle High Schools.

3. <u>RECOMMENDED MOTION</u>

I move that the School Board authorize the Superintendent to execute construction contract K5088 with Wayne's Roofing, Inc., utilizing the E & I Cooperative Services purchasing agreement, for Ballard and West Seattle High Schools Roof Replacement project, in the amount of \$9,361,358, plus Washington State sales tax, in the form of the draft agreement attached to the Board Action Report, with any minor additions, deletions, and modifications deemed necessary by the Superintendent, and to take any necessary action to implement the contract.

4. <u>BACKGROUND INFORMATION</u>

a. Background

The initial scope of work for these projects included replacement and/or repairs to a portion of the existing roof at each site as described below. In addition, the selected architect and envelope consultant conducted further investigation to determine the extent of possible moisture intrusion pathways and detail needed repairs. During the course of their investigation, additional problems were identified at each school and Capital Projects is recommending these be addressed under this contract to ensure all moisture intrusion problems are resolved.

At Ballard High School the Buildings, Technology and Academics (BTA) IV Capital levy included the replacement of the entire single-ply roof assembly. The investigation revealed that the gymnasium steep slope standing seam metal roof was in poor condition as it is inappropriately fastened and should be removed and correctly attached to prevent moisture intrusion. In addition, the sheet metal wall panel cladding system on the back side of the roof parapet has no weather resistant barrier and must be removed, substrate repaired and then reattached to prevent moisture intrusion. The most recent major roof and envelope project at Ballard High School was the original construction in 1999.

At West Seattle High School, the BTA IV Capital Levy included the repair of the north facing historic clay tile roof. The investigation revealed there are numerous problems with the south facing historic clay tile roofs, central ridge walkway, the cupolas and the existing skylight. In addition, it was determined the historic tile installation attachment (batten/counter-batten system) should be revised to minimize the amount of penetrations through the subroofing system, enhancing moisture migration and airflow. The most recent major project at West Seattle was the Addition/Remodel in 2002 and did not include the historic roofing system.

The contract amount is based on the district's proposal received from Wayne's Roofing, Inc. The proposal was developed utilizing the E & I Cooperative Services purchasing agreement which was competitively bid and subsequently awarded to Wayne's Roofing, Inc. Wayne's Roofing has been heavily involved in the investigation and design phase so we anticipate minimal change orders to these projects.

b. Alternatives

If the contract is not awarded, the planned schedule for this capital construction project will not be maintained and this work will not be performed. Furthermore, there has already been substantial water-related damage at both sites and if not remedied will continue to expand, causing future repair to be more disruptive to the educational mission of the district and generating greater repair time and costs. Therefore, this alternative is not recommended.
