## 1. <u>TITLE</u>

BTA III/BEX IV: Approval of Budget Transfer and Award Construction Contract for the Lafayette Elementary School Seismic, Fire Sprinkler & HVAC Upgrades project

## 2. <u>PURPOSE</u>

The purpose of this action is to provide authorization for the Superintendent to approve a onetime fund transfer in the amount of \$275,000 from the Buildings, Technology, and Academics/Athletics (BTA) III Program Contingency, and authorize the Superintendent to enter into a construction contract in the amount of \$3,045,500, plus Washington State sales tax, for the Lafayette Elementary School project.

# 3. <u>RECOMMENDED MOTION</u>

I move that the School Board approve the transfer in the amount of \$275,000 from the BTA III Program Contingency to the Lafayette Elementary School Seismic, Fire Sprinkler & HVAC Upgrades project budget and authorize the Superintendent to execute construction contract P5155 with Kassel & Associates, Inc., in the amount of \$3,045,500, including base bid plus Alternate #2, plus Washington State sales tax, with any minor additions, deletions, modifications and actions deemed necessary by the Superintendent to implement the contract.

# 4. <u>BACKGROUND INFORMATION</u>

## a. Background

The Lafayette Elementary School Seismic, Fire Sprinkler & Heating, Ventilation, and Air Conditioning (HVAC) Upgrades project, located at 2645 California Ave. SW, Seattle, WA 98116, is funded through the BTA III Capital Levy passed by the voters in February 2010 and the Building Excellence (BEX) IV Capital Levy passed by the voters in February 2013. Completion of this project is scheduled for August 2021 prior to commencement of the 2021-22 school year.

The Lafayette Elementary School Seismic, Fire Sprinkler & HVAC Upgrades project was publicly bid on November 4, 2020, and four contractors submitted bids. The scope of work for this project includes seismic upgrades, installation of a fire sprinkler system throughout the building, replacement of the existing steam boiler with two condensing hot water boilers, and replacement of fan coil units in the classrooms.

This motion allows the transfer of \$275,000 funds from the BTA III Program Contingency to the Lafayette Elementary School Seismic, Fire Sprinkler & HVAC Upgrades project budget. The transfer will adjust the original project budget of \$4,411,225 to the current estimated total project budget of \$4,686,225. The BEX/BTA Oversight Committee was apprised of a need for a budget transfer for this project at their meeting of November 13, 2020.

This motion allows the district to execute a construction contract with Kassel & Associates, Inc., who was the low responsive, responsible bidder.

#### b. Alternatives

Deny Motion. If motion is denied, the district will not be able to execute the contract to start construction on the Lafayette Elementary School Seismic, Fire Sprinkler & HVAC Upgrades School project. Not funding the adjustment of the project budget would negatively impact project success in meeting district educational specifications and operational goals. This is not recommended because it would negatively impact the district's commitment to provide equitable access in our schools.

#### 5. <u>FISCAL IMPACT/REVENUE SOURCE</u>

This motion will authorize the transfer of \$275,000 from the BTA III Program Contingency and authorize a construction contract in the amount of \$3,045,500, plus Washington State sales tax. The overall project budget as adjusted is shown below:

The selection of projects in the BTA III and BEX IV programs went through an extensive community vetting process and ultimately received 73% approval from voters in February 2010 (BTA III) and 72% approval in February 2013 (BEX IV)

# 7. <u>EQUITY ANALYSIS</u>

The selection of projects in the BTA III and BEX IV Capital Levy programs was done in 2009 and 2012 and was intended to address capacity needs and inadequate building systems in school facilities across the city. As such, this motion was not put through the equity analysis as would be done as part of the district's current capital planning efforts.

# 8. <u>STUDENT BENEFIT</u>

It is the goal of the district to continue the process of implementing the BTA and BEX Capital Levy programs and to provide students with safe and secure school buildings.
