#### 1. TITLE

Distressed School Grant Award Construction Contract P5177, Bid No. B102018, to FORMA Construction Company for the Madison Middle School Eight Classroom Addition project and Budget Transfer

#### 2. PURPOSE

The purpose of this action is to authorize the Superintendent to enter into a construction contract in the amount of \$8,289,400, including base bid plus alternates No.2, No.3 and No.4b plus Washington State sales tax, for the Madison Middle School Eight Classroom Addition project and allow a one-time fund transfer in the amount of \$360,000 from the Building, Technology and Academics/Athletics (BTA) III Core 24 Allocation for the creation of two new science classrooms (added conversion costs from General Education Classroom to Science Classroom) and \$1,455,064 from the Building Excellence (BEX) V Program Contingency.

#### 3. <u>RECOMMENDED MOTION</u>

I move that the School Board authorize the Superintendent to enter construction contract P5177 with Forma Construction Company in the amount of \$8,289,400, plus Washington State sales tax, with any minor additions, deletions, modifications and actions deemed necessary by the Superintendent to implement the contract and allow a budget transfer in the amount of \$360,000 from the Building, Technology and Academics/Athletics (BTA) III Core 24 Allocation for the creation of two new science classrooms and \$1,455,064 from the Building Excellence (BEX) V Program Contingency

#### 4. BACKGROUND Information

#### a. Background

The Madison Middle School Eight Classroom Addition project, located at 11725 1<sup>st</sup> Ave. NE Seattle, WA 98125 is funded through the Office of Superintendent of Public Instruction (OSPI) Distressed School Grant. Completion of this project is scheduled for August 2022 prior to commencement of the 2022/23 school year.

The Madison Middle School Eight Classroom Addition project was publicly bid on May 12, 2021 and a total of five contractors submitted bids. The project scope includes the

design and construction of a new eight classroom building addition on the existing 7.92 – acre site. The project will relieve overcrowding at the school and the existing portables will be removed. The new school addition will meet the requirements outlined in the District's middle school educational specifications.

This motion allows the district to execute a construction contract with Forma Construction Company, who was the lowest responsive, responsible bidder.

The Madison Middle School Eight Classroom Addition project budget will be increased with a transfer of \$360,000 from the BTA III Core 24 Allocation and \$1,455,064 from the BEX V Program Contingency. The transfer will adjust the original Madison Middle School Eight Classroom Addition School project budget of \$10,500,000 to the current estimated total project budget of \$12,315,064.

The school was constructed in 1929. Prior improvements that have been made at Madison Middle School since the year 2000 include 2008 remodel and building addition and 2016 CCTV upgrades.

#### b. Alternatives

Deny Motion. If the motion is denied, the district will not be able to execute the contract to start construction on the Madison Middle School Eight Classroom Addition School project. Not funding the adjustment of the project budget would negatively impact project success in meeting district educational specifications and operational goals. This is not recommended because it would negatively impact the district's commitment to provide equitable access in our schools.

#### 5. FISCAL IMPACT/REVENUE SOURCE

The fiscal impact to this motion will be \$8,289,400, plus Washington State sales tax. The revenue source for this motion is funded by the \$10,500,000 Distressed School grant from the Office of Superintendent of Public Instruction (OSPI). The total project budget, of which the

construction contract is one part, is \$12,315,064. To support the contract authorized under this motion, \$360,000 would be transferred from the BTA III Core 24 Center and \$1,455,064 would be transferred from the BEX V Program Contingency to the project budget. The overall project budget is adjusted as shown below:

The selection of projects in the BEX V Levy program went through an extensive community vetting process and ultimately received 73% approval from voters in February 2019. This project was not selected to be part of the BEX V Levy, but it was part of the community vetting process for selecting BEX V projects.

#### 7. EQUITY ANALYSIS

Selection of capital projects submitted for State of Washington - Distressed School Grant consideration was intended to address student capacity needs and inadequate building systems in school facilities across the city. As such, this motion was not put through the equity analysis as it would have been done for the district's current capital planning efforts.

#### 8. <u>STUDENT BENEFIT</u>

It is the goal of the district to continue the process of implementing the BTA and BEX Capital Levy programs and to provide students with safe and secure school buildings.

#### 10. POLICY IMPLICATION

Per Board Policy No. 6220, Procurement, all contracts for the procurement of goods and services related to capital construction projects that have been previously approved by the Board must be brought before the board for approval if the initial value exceeds \$5,000,000, excluding sales tax and contingencies.

Board Policy No. 6000, Program Planning, Budget Preparation, Adoption, and Implementation, item number D, provides that "Funds may be transferred from one budget classification to another subject to such restrictions as may be imposed by the Board." While this budget transfer does not require Board approval under Board Policy No. 6000, Board approval for this budget transfer is being requested for transparency.

The district has had a practice of seeking Board approval for capital project budget transfers exceeding the contract threshold identified in Board Policy No. 6220, Procurement. This practice was discussed with the Operations Committee on May 6, 2021, given recent changes to the approval thresholds under Policy No. 6220. The Operations Committee provided feedback that transfers should be reviewed by the Board when the amount exceeds \$500,000, consistent with the threshold for Board approval of any changes or amendments to contracts.

#### 11. BOARD COMMITTEE RECOMMENDATION

This motion was discussed at the Operations Committee meeting on June 3, 2021. The committee reviewed the motion and moved the item forward with a recommendation for approval by the full Board.
