1. <u>TITLE</u>

BTA III/ BTA IV: Resolution 2018/19-21, Final Acceptance of Contract K1303 with Aries Building Systems, LLC, for the Purchase and Installation of Portable Classroom Modules project

2. PURPOSE

The purpose of this action is to approve final acceptance of Contract K1303 with Aries Building Systems, LLC, for the Purchase and Installation of Portable Classroom Modules project. Board approval allows the district to submit required documents to the State of Washington Department, of Labor & Industries, Department of Revenue, and Employment Security Department, and closeout the project, including authorizing the release of project retainage.

3. RECOMMENDED MOTION

I move that the School Board adopt Resolution 2018/19-21 and accept the work performed under Contract K1303 with Aries Building Systems, LLC, for the Purchase and Installation of Portable Classroom Modules project as final.

4. BACKGROUND INFORMATION

a. **Background**

- The project was funded by BTA III/ BTA IV capital funds to support installation of portable classrooms that address the annual requirement of providing classroom solutions for the district's enrollment growth and program needs.
- At the January 17, 2018 School Board Meeting, the Board authorized the Superintendent to execute contract No. K1303 with Aries Building Systems, LLC. The Board action approved \$1,282,392 for the installation of portable classrooms and included authorization to execute change orders for additional purchases, move-in, and set up of classroom/portables up to an additional \$500,000 specific to contract No. K1303 annual capacity management classrooms/portables actions.

- The district publicly advertised Bid No. B11716, Purchase and Installation of Portable Classroom Modules project on December 1, 2017, with a total number of three (3) bids received. Aries Building Systems, LLC, was deemed to be the low bid contractor, and the consulting firm Rolluda Architects recommended acceptance of the Total Bid amount, including unit prices. By Summer 2018, the Capital Enrollment and Planning Annual Capacity Management actions identified that it would not be necessary to execute a change order(s) for additional classrooms/portables.
- Aries Building Systems, LLC satisfactorily completed the contract work to manufacture, transport, and install a total of seven (7) classrooms/portables at three (3) school sites (1-classroom at Coe Elementary School, 2-classrooms at Ingraham High School, and 4-classrooms at Robert Eagle Staff Middle School) based on a total of 3-single portables and 2-double portables. There is a significant overall contract savings of 47% based on owner-directed reduction of contract scope (deletion of contract unit price quantities; 3-singles and 2-doubles) and a moderate amount of owner-directed expenditures for other design requirements and/or site-specific construction constraints (amounts listed further below). In accordance with WAC 392-344-160, Board approval of final acceptance is required.

b. Alternatives

Not accepting the project in a timely manner could put the district in a position subject to litigation. Therefore, this alternative is not recommended.

c. Research

The capacity management recommendations were based on a collaborative process involving staff from Capital Planning, Enrollment Planning, Special Education and Early Learning, plus subject matter research and analysis regarding projected enrollment growth, program needs, the available space in existing permanent and portable facilities, and site-specific potential to support an additional building footprint.

5. FISCAL IMPACT/REVENUE SOURCE

All payments have been made to the contract from the BTA III/ BTA IV Capital Levy funds. No outstanding invoices remain.

During the course of the project three (3) Change Orders were issued comprised of five (5) Change Order Proposal Requests and two (2) Construction Change Directives. Cumulative Change Orders totaled a Net Deduct of (\$611,312) plus WSST. Change order savings totaled an overall 47% of the awarded construction contract amount with significant savings associated with the deletion of awarded contract unit price quantity portables (deleting 3-singles and 2-double portable structures). Change order expenditures were reasonable for this type of capacity management portables project.
