#### 1. <u>TITLE</u>

Approval to name the Daniel Bagley Elementary School primary wing (south first floor) in honor of Mrs. Barbara Stone

#### 2. <u>PURPOSE</u>

This Board Action Report details the recommendation from Principal Carla Holmes that the Daniel Bagley primary wing be named in honor of Mrs. Barbara Stone, a longtime Kindergarten teacher at Daniel Bagley Elementary School.

#### 3. <u>RECOMMENDED MOTION</u>

I move that the School Board approve the naming of the Daniel Bagley Elementary School's primary wing as the *Barbara Stone Primary Wing*.

#### 4. <u>BACKGROUND INFORMATION</u>

a. **Background:** Kindergarten teacher Barbara Stone worked at Daniel Bagley for 48 years, starting in 1969 and retiring in 2017. As an individual who dedicated their career to the students of Seattle Public Schools and Daniel Bagley Elementary, it is the recommendation of Principal Carla Holmes and the school building leadership team to name the primary wing located on the southern first floor of the building in Ms. Stone's honor.

As a teacher, she was known for her skill, dedication, and caring. One teacher described her as the most organized teacher they had ever known. A former student credited her with not only teaching you math and writing, but also how to be a kind friend and good citizen. In addition, she was recognized for her ability to teach many kids how to read and write at a very young age because of her outstanding teaching style.

A favorite part of being in Ms. Stone's class, mentioned by almost all former students and parents, was the fact that she would bake a cake the night before every student's birthday that was their favorite flavor and it would be waiting for them on their desk in the morning when they arrived. Then, the birthday student could pick the friends they wanted to frost their cake with. One former student said this was an example of how Ms. Stone "made everyone in the classroom feel welcomed, important, and cared for, no matter what." Pursuant to Board Procedure 6970BP, Principal Carla Holmes sought feedback from staff, students, alumni and community residents in regard to the naming opportunity. All feedback received was overwhelming in support of the proposed naming. In addition, the naming opportunity was discussed by Daniel Bagley's building leadership team and they unanimously voted in favor to name the wing in Ms. Stone's honor.

- b. Alternatives: No alternatives were considered.
- c. **Research:** Daniel Bagley Elementary School is proposing to name its kindergarten wing after longtime kindergarten teacher Barbara Stone. Several schools in Seattle Public Schools have named their grade level wings, among them:
  - Highland Park Elementary School *LouAnne Rundall Library* named after a former longtime library volunteer.
  - Ingraham High School *Walt Milroy Court,* named after former men's head basketball coach at Ingraham High School

#### 5. <u>FISCAL IMPACT/REVENUE SOURCE</u>

Tier 2: Consult/Involve – In accordance with Board Procedure No. 6970 BP, Principal Carla Holmes prepared a report explaining the process of determining the name for the new Daniel Bagley wing. Principal Holmes explains that the name was proposed by several community members and previous students. After receiving the Superintendent's approval, the Daniel Bagley Building Leadership Team (BLT) reviewed the proposed name and unanimously approved the recommendation. The BLT then sought feedback from school and community members through community newsletter and postings. Daniel Bagley received letters and emails of support from a) current and former staff, parents, and student, b) community members who were on the SDAT or who live in the neighborhood. The relevant feedback received demonstrated overwhelming support for this recommendation. There were many requests to be invited to any naming announcement ceremony.

#### 7. <u>EQUITY ANALYSIS</u>

We did not use the Racial Equity Analysis Tool in our recommendation, as we did not deem it applicable for this decision.

#### 8. <u>STUDENT BENEFIT</u>

From Abby Holmes, current 5<sup>th</sup> grader at Daniel Bagley - *I had the pleasure of being in Ms.* Stone's class as a kindergartener. I believe we should name the kindergarten wing at the new school after Ms. Stone. She has dedicated her life to the students at Daniel Bagley

... She made everyone in the classroom feel welcomed, important, and cared for no matter what.

In conclusion, by naming the kindergarten wing after Barbra Stone we would be honoring and celebrating the many contributions to students and staff. The Bagley community will continue to carry on the tradition of caring and service in her name.

#### 11. BOARD COMMITTEE RECOMMENDATION


This motion was discussed at the Operations Committee meeting on September 10, 2020. The Committee reviewed the motion and moved the item forward for approval by the full Board.

#### Introduction

The School Board does not favor changing the names of existing School District buildings or portions of buildings. However, occasionally a change in the name of a school building or a portion of a building may be appropriate. Also, from time to time it may be necessary to name a new building or name a portion of a building. Before any name change and any naming of a new building or portion of a building is finalized, school and community input shall be sought.

#### **Procedure**

- 1. Initial Naming of a Building
  - a. The opportunity to name a new building comes about as a result of new construction. Replacing an existing building, either at the same or a new site, is not considered new construction for the purpose of this procedure. (See paragraph 5 below).
  - b. Names of new buildings should be selected based upon: (i) geographical location or local community name; or (ii) distinguished individuals who have served the local community, state, or nation, whether in education or other fields.
  - c. Whenever the opportunity to initially name a building is presented, the Superintendent will request the principal or appropriate District administrator to meet with community residents and other interested individuals to discuss the naming opportunity. If a name is proposed centrally, the school community will be asked to review the proposed new name. Otherwise, the school community will be asked to recommend a name or names.
  - d. The principal or appropriate administrator should prepare a written report summarizing school and community recommendations for the proposed new name. The report should be submitted to the Superintendent. The Superintendent shall then make a recommendation to the Board.

- e. The Board will accept or reject the proposed name(s).
- f. When a name is approved, the Superintendent shall send a notification of the name to the appropriate offices, locations, and persons.
- 2. Initial Naming of a Portion of School Building
  - a. Portions of a school include rooms, auditoriums, gymnasiums, athletic fields, libraries, and the like.
  - b. The opportunity to name a portion of a building or name a portion of a new building could come about for a number of reasons, including new construction or in recognition of a gift or other funding opportunity.
  - c. The name of a portion of a building should be selected based upon:
    (i) geographical location or local community name; or (ii) distinguished individuals who have served the local community, state, or nation, whether in education or other fields.
  - d. In the case of naming in recognition of a gift, the name could also be that of an individual donor or member of the donor's family. Corporate names of rooms and portions of buildings will not be allowed. Nothing in this policy shall preclude the placement of an appropriately-sized plaque, name plate, or donor wall in a room or other portion of a school in recognition of a corporate gift, provided no advertising, as opposed to recognition, is involved. Plaques, name plates, and donor walls are governed by Board Policy No. 6115.
  - e. Whenever the opportunity to name a portion of a building is presented, the Superintendent will request the principal to meet with staff, students, alumni, and community residents to discuss the naming opportunity. If the school has a site council, it shall be included in such meetings. If a name is proposed centrally, the school community will be asked to review the proposed new name.
  - f. The principal should prepare a written report summarizing school and community recommendations for the proposed new name. The report should be submitted to the Superintendent. The Superintendent shall then make a recommendation to the Board.
  - g. The Board will accept or reject the proposed name change.

- h. If the change is approved, the Superintendent sends a notification of the change to the appropriate offices, locations, and persons.
- 3. School Building Name Change

Since a proposal to change a school building name could originate from many sources, the following steps should be taken:

- a. The person(s) proposing the name change should present the proposal to the Superintendent.
- b. If the Superintendent decides the school name change should be considered, he or she will request the principal meet with staff, parents, students, alumni, and community residents to discuss the proposed change. If the school has a site council, it shall be included in such meetings. The principal should prepare a written report summarizing school and community support of and/or opposition to the proposed change. This report should be submitted to the Superintendent.
- c. If the building is named after a local person, a good faith effort must be demonstrated to contact and seek input from the relatives of that person (e.g., Internet search, legal ads, phone book, daily newspaper) before the name change is approved.
- d. If the Superintendent approves of the name change, the proposed change will be submitted to the Board.
- e. The Board will accept or reject the proposed name change.
- f. If the change is approved, the Superintendent sends a notification of the change to the appropriate offices, locations, and persons.
- 4. Changing the Name of a Portion of a Building

The procedure for changing the name of a portion of a building shall be the same as for changing the name of the building itself.

5. Replacement Buildings

When a building is torn down and replaced, either at the same location or a new location, it should retain the same name unless the procedure for school building name change is followed.

6. Program Names

## Naming and changing the name of programs shall be within the authority of the Superintendent.

Dear Ms. Holmes:

Along with Jennifer Greenfield and several other Danial Bagley Elementary School neighbors and parents, in the late 1990s and early 2000s I was a member of the Daniel Bagley Site Council. I was a member of various committees (ground maintenance, grounds improvement, technology and grants).

I was the main draft person responsible for grant funding requests which, happily, resulted in Daniel Bagley being awarded \$113,000 over a period of five years to help establish the Montessori program at the school.

This is a letter justifying, hoping and supporting the naming of the new primary wing in honor of Barbara Stone.

I will speak first as a teacher who worked with her for 15 years and then substituted in her room for 15 years after I retired. Barbara was the most organized teacher I ever met. When we first met, she taught me to use file folders. Simple, I know but it demonstrates how she helped every new teacher who came into Bagley. She shared her lessons, her materials, her enthusiasm for teaching freely. Not only did she work tirelessly in her classroom, she supported the projects that built the Bagley community, peer tutoring, all school environmental fieldtrips, the contemporary program and the joining with the Montessori program. Her tireless work for the community helped turn Bagley that had a year before closing to a school with a long waiting list.

Watching her work with her students and parents was inspiring. She would conference regularly with parents of student with problems. So many of them came back years later with the thanks for the start they needed. She was a tireless teacher of reading. I learned how good she was as a substitute. Her file folders for each reading group were packed. I would always make the joke that it was my personal goal to do it all for each group in the time given; never could quite make it. She made sure every student for all those years got a birthday cake she baked the night before. The student then got to frost with a friend or two they picked before serving. Her Thanksgiving feast was the total meal with her wonderful husband, Gary, carving the turkey.

Barbara was always quiet about her successes. She never wanted any praise. She did what she did because she loved being a teacher and a part of the Bagley community. When her husband became permanently disabled she knew her job had to be his care and retired quietly with no recognition. I grew up in Seattle Schools, Montlake, Meany and Garfield and taught at Hamilton, Madrona, and Bagley for many years each. I can not think of a single person who worked harder and with more love than Barbara Stone. She is very deserving of this honor and hope she is considered seriously. She was a one of a kind teacher to her own students and parents and the entire Bagley community.
