1. TITLE

BEX IV: Resolution 2016/17-25: Resolution of New-in-Lieu Replacement Option for the Wing Luke Elementary School Project

2. PURPOSE

School Board Approval of Resolution 2016/17-25 is required by the Washington Administrative Code (WAC) 392-347-042 as part of the Form D-3 approval process to receive state funding assistance for the Building Excellence (BEX) IV Program for Wing Luke Elementary School. If the existing space of the building to be replaced is returned to instructional use, the District will not be eligible for any state school construction funding assistance for a period of ten years.

Eligibility for state matching funding for new construction in lieu of modernization is based upon the square footage of the existing building, which is 58,573 sq ft. The square footage of the new Elementary School exceeds that of the existing facility, so the entire amount of eligibility will be utilized on the new school.

3. RECOMMENDED MOTION

I move for approval of Resolution 2016/17-25, which certifies that the existing space at the Wing Luke Elementary School, to be replaced through new construction in lieu of modernization will not be used in the future for District instructional purposes or be eligible for future state financial assistance.

4. BACKGROUND INFORMATION

a. Background

The current design of the Wing Luke Elementary School requires demolition of the existing buildings and replacement with new construction in lieu of modernization. The replacement is primarily due to major deficiencies with the existing buildings.

b. Alternatives

Do not approve the Wing Luke Elementary New Construction-In-Lieu of Modernization Resolution 2016/17-25. This is not recommended. If the state assistance funding

requirements are not met, the District will not receive the state assistance funding for this project.

5. FISCAL IMPACT/REVENUE SOURCE

The Wing Luke Elementary School project funding source is from the BEX IV Capital Levy and anticipated state assistance funding.

If this Resolution is not approved in a timely manner, the state funding assistance for the new construction in lieu of modernization at Wing Luke, will not be forthcoming. This Resolution is a requirement of the State D-3 Application for Assistance. Approximately \$2 million in state assistance funding is anticipated for new-in-lieu construction.
