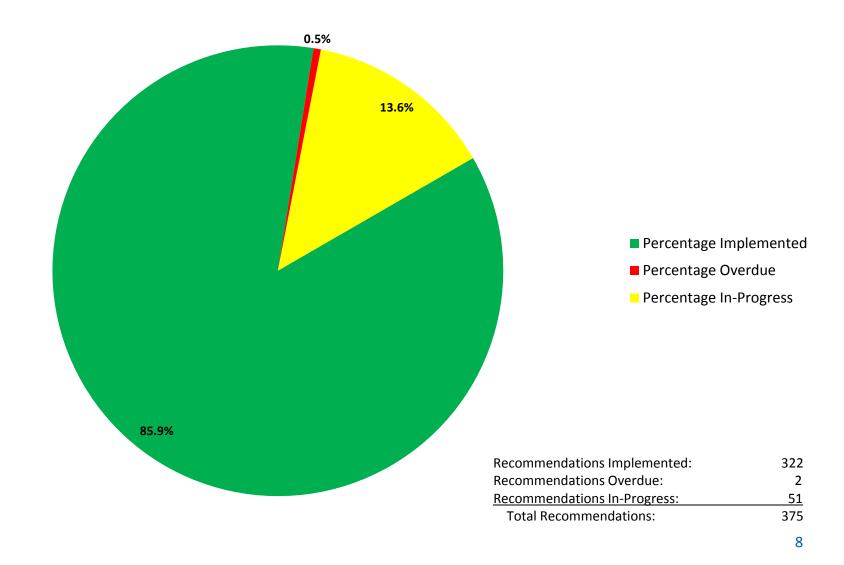

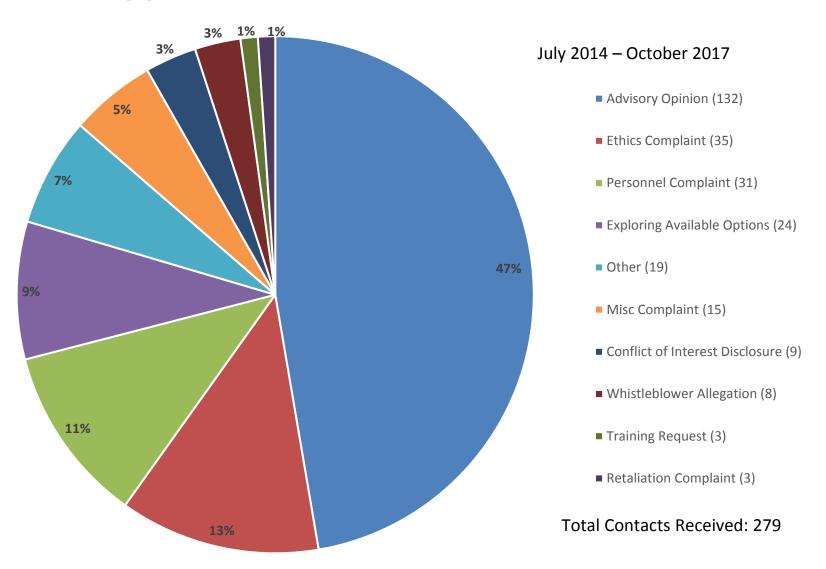

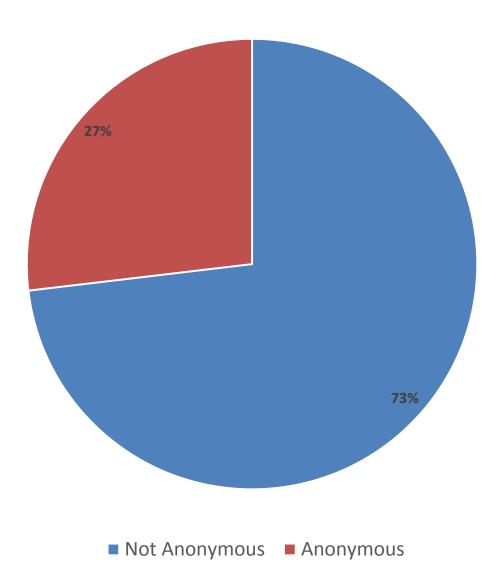
- Requires an annual report to the School Board within 90 days of fiscal year end.

Types of Contacts Received

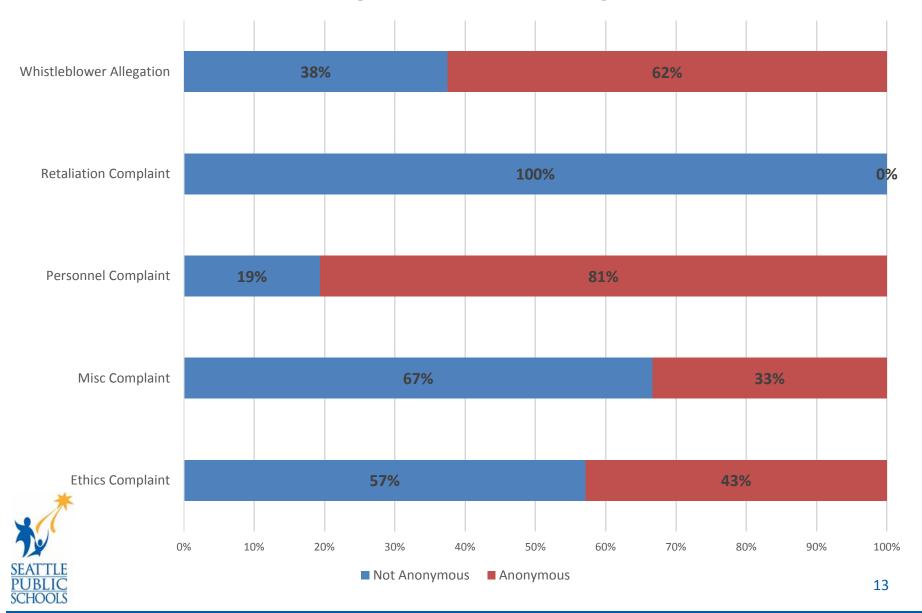


Anonymous Contacts

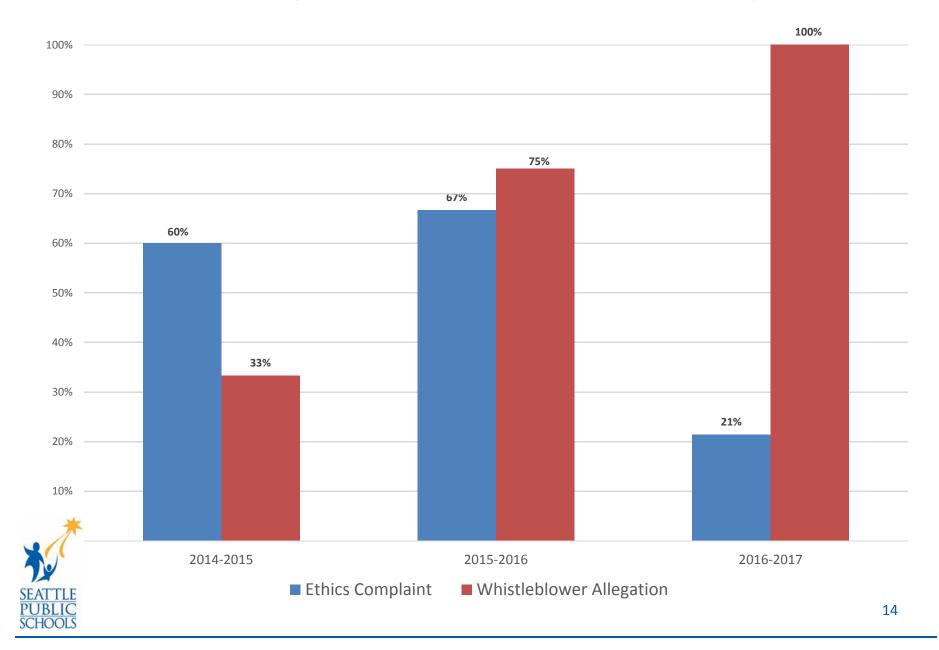




Anonymous Complaints
