Annual Fixed Asset Report – Capitalization Thresholds

In addition to tracking equipment costing more than \$5,000, additional theft-sensitive assets are tracked in accordance with the following thresholds:

Computers, Laptops, iPads, Tablets	All items tracked regardless of amount
Computer Peripherals (e.g., printers)	\$500
Audio/Visual Equipment (e.g., TV, Document Camera)	\$500
Non-Computer Office Equipment (e.g., laminator)	\$1,000
Shop Tools & Automotive Equipment	\$1,000
Kitchen & Custodial Equipment	\$1,000
Grounds & Garden Equipment	\$1,000
