### 1. TITLE

BEX V and K-3 Class Size Reduction Grant: Award Architectural & Engineering Contract P1666 to Miller Hayashi Architects for the West Seattle Elementary School Addition project

### 2. PURPOSE

The purpose of this action is to provide authorization for the Superintendent to enter into Architectural & Engineering (A/E) contracts for the following items related to the West Seattle Elementary School Renovation and Addition project:

- a. Authorize the Superintendent to enter into an Architectural & Engineering (A/E) contract in the amount of \$2,231,962, plus reimbursable expenses not to exceed \$30,000.
- b. Allow transfer of \$4,400,000 from the K-3 Class Size Reduction Grant to the West Seattle Elementary School Renovation and Addition project to construct a twelve-classroom addition.

## 3. RECOMMENDED MOTION

I move that the School Board authorize:

- a. The Superintendent to execute A/E contract P1666 with Miller Hayashi Architects in the amount of \$2,231,962, plus reimbursable expenses of \$30,000 for architectural and engineering services for the West Seattle Elementary School Addition and Renovation project, with any minor additions, deletions, and modifications deemed necessary by the Superintendent, and to take any necessary actions to implement the contract; and
- b. To allow transfer of \$4,400,000 from the K-3 Class Size Reduction Grant to the West Seattle Elementary School Renovation and Addition project to construct a twelve-classroom addition.

#### 4. BACKGROUND INFORMATION

### a. Background

The West Seattle Elementary School Addition and Renovation project, located at 6760 34th Ave SW, Seattle, WA 98126, is funded through the Building Excellence V (BEX V)

levy passed by the voters in February 2019. The levy timeline includes that this project will be completed for the 2022 school year.

The project scope includes modernization of the existing building, adding an additional twelve (12) classrooms with three (3) learning commons providing for 500 students and offsite improvements.

The firm of Miller Hayashi Architects was selected through the Architecture and Engineering (A/E) selection procedures established in Superintendent Procedure 6220SP.C. Ten (10) firms submitted their qualifications and Three (3) firms were shortlisted and interviewed, DOWA – IBA Group Architects, Miller Hayashi Architects, and Studio Meng Strazzara were interviewed. Miller Hayashi was judged to be the most qualified to provide these design services.

There have been no prior improvements that have been made at West Seattle Elementary School. The reason for the K-3 Class Size Reduction Grant transfer is to create additional K-3 classrooms.

#### b. Alternatives

Deny Motion. If motion is denied, the district will not be able to execute the contract to start the design of the West Seattle Elementary School Addition and Renovation project.

### 5. FISCAL IMPACT/REVENUE SOURCE

The fiscal impact to this motion will be \$2,261,962. The revenue source for this motion is from the BEX V levy and the transfer of K-3 Class Size Reduction Grant in the amount of \$4,400,000. The advertised Maximum Allowable Construction Cost budget is \$19,100,000, the total project budget is \$28,216,878 of which the A/E contract is one part.
