1. The adoption coordinators welcomed committee members, re-introduced adoption leaders and shared the meeting agenda.
2. Some committee members reported that they were unable to access the chat feature in MS Teams. The adoption coordinators spent some time troubleshooting and developing workarounds to the MS Teams Chat to quickly share textual information.
3. The individual committee members introduced themselves to the whole group.
4. The committee members reviewed the expectations of selection committee participants – including completing a Conflict-of-Interest agreement and associated background reading of School Board Policy 5251 – Ethics, and Evaluation Procedures for Committee Team Members.
5. The Adoption committee reviewed a proposed decision-making process. Using the proposed process there was a motion to vote, it was seconded, and with a unanimous vote the motion carried to approve the decision-making process.
6. The adoption committee reviewed proposed amendments to group norms from our previous (9/11/2021) meeting. Using the decision-making-process, amendments* were added to the list

of committee norms. The committee used the decision-making process to approve the amended norms.

7. The adoption committee read the executive summary of the National Council of Teacher of Mathematics publication *Principles to Action*, shared and discussed important excerpts relevant to developing selection criteria.
8. The adoption committee reviewed requirements of the Seattle Public Schools purchasing department prior to submitting 'Requests for Proposals' (RFP). Specifically, the committee must develop 'a general description of categories which will be used to evaluate materials' before an RFP can be submitted.
9. The adoption committee reviewed categories – and the assigned evaluation weight of each category – from previous instructional materials adoptions (Elementary ELA, Science, and Middle School Math). A set of categories was proposed.
10. The adoption committee moved into breakout groups to discuss the proposed categories, develop suggestions to add new, or to delete or consolidate existing categories.
11. The adoption committee reconvened to discuss understandings and hear proposals.
12. As the meeting time neared the end, the adoption committee decided that we would continue the work of amending and assigning weights to the evaluation categories at the next gathering - Monday, October 4th at 5:00 pm.
