Board Policy 6114: Gifts, Grants, Donations, and Fundraising Proceeds.

What is Board Policy #6114?

It is the policy of the Seattle School Board to actively encourage cooperation with individuals and governmental and non-governmental organizations as well as from private and foundation sources desiring to provide resource assistance to the district. Such assistance may take the form of direct financial support, grants, services, supplies or equipment. Where resource assistance is offered, the district shall make a determination whether to accept the assistance and upon what terms. Any requirement to contribute district funds or other resources shall be documented and considered as part of the approval process and reflected in budgets. Acceptance shall be in confirmed in writing.

What is our current process?

All grants, gifts and donations currently follow the approval authority outlined in Board Policy # 6114 up to \$250,000. Should a Gifts, Grants, Donations and Fundraising Proceeds be more than \$250,000 in a fiscal year, then it will be presented to the Board of Directors for approval and acceptance.

What growth opportunities do we envision?

The District believes incorporating a leveled grant, gifts and donations policy would allow the business processes to speed up the acceptance of specific funding sources to support District initiatives.

An important consideration to implement a leveled acceptance model is the Boards of Director's philosophy on Parent organization funding at the school level. By establishing a leveled acceptance of funds, Federal, State and Foundation Competitive grants would have a higher threshold for acceptance by the Board of Directors than Parent Organization gifts, grants, donations and fundraising proceeds.
