Budget

BAR – Approval of RFP NO. 012238

Mr. Del Valle discussed the BAR (Board Action Report) for Approval of SPS computer device contract to support 1:1 teacher and learning. Mr. Del Valle displayed the BAR for committee members to review.

Craig asked how the contracted amount stated in the BAR compared the amount previously paid for devices. Director of Technology Infrastructure Jay McSweeny replied the device prices are comparable.

Jacqui asked was the amount was for a 2-year period or if that amount was for each year of the contract. Jay replied the contract is 2 years with two one-year options for a total of 4 years, potentially.

Wireless U of W Pilot Update

Jay McSweeny and Senior Network Engineer Devin Miller shared a presentation on Seattle Community LTE Pilot at SPS

Jacqui asked question regarding coverage. Devin replied the focus is on augmenting what we're doing with hotspots for other carries but specifically for students near to these schools. Jacqui followed up asking if this is to help reduce the dependency on hotspots. Devin replied it's just like cell phone coverage from large carries. The coverage is about ½ mile coverage, and it can expand out to 2 miles.

Benjamin asked what are we envisioning for governance of the network? Would it be under SPS purview or a separate network? Information Security Manger April Mardock replied we would make it safe for kids so we would still ask for basic filtering.

School Leader Annual Dashboard

Business Intelligence Manager Philip Ramunno shared a presentation on School Leader Annual Data.

Craig asked if the dashboard was custom built or built on an existing platform. Philip answered it was built using Power BI.

Jacqui asked why it's called School Leader Board. Philip replied the audience is for school leaders. The report is to help with planning and not a progress monitoring tool.
