AUDIT RESULTS

Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

About the audit

This report contains the results of our independent accountability audit of Seattle School District No. 1 from September 1, 2020 through August 31, 2021.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the Washington State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the District's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the year ended August 31, 2021, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Use of restricted funds professional learning and local revenue for enrichment activities
- Compliance with supplemental contracts for enrichment activities
- Payroll direct deposits evaluated design of controls
- Self-insurance unemployment and workers compensation
- Maintenance Department fuel card controls and District vehicle conditions of use agreement
- Newly elected board members conference attendance of the Washington State School Directors' Association
- West Seattle Elementary School parcel exchange

- Closure of Interagency Academy instructional sites
- Open public meetings opportunity for public comment and meeting notice for the March 4 and March 11, 2022 board meetings
- Open public meetings compliance with minutes, meetings and executive session requirements
- Financial condition reviewing for indications of financial distress

INFORMATION ABOUT THE DISTRICT

Seattle School District No. 1 serves more than 52,000 students and operates 18 high schools, 13 middle schools, 11 K-8 schools, and 63 elementary schools (including 15 option schools, 7 Alternative Learning Experience schools with continuous enrollment, and three service schools).

District activities are monitored by an elected, seven-member Board of Directors. The Board oversees the governance of the District and appoints a Superintendent to oversee the District's operations. The District had General Fund expenditures of \$973.8 million for the 2020-2021 school year.
