John motioned to approve the November 21 ITAC Agenda. Jian seconded the motion. The motion passed unanimously.

Robert motioned to approve the October 24, 22 ITAC Meeting Minutes. John seconded the motion. The motion passed unanimously.

### Budget

Carlos went over the current budget. Mr. Del Valle mentioned there may be some restrictions with the general fund.

### **Cybersecurity Update**

Information Security Manager April Mardock gave a cybersecurity update that discussed Board Policy and Network Use Agreement, Cybersecurity at SPS, Systems Control, Best Practices, and Privacy and Contract management.

John asked does the company that monitors cyber-attacks give alerts in real time. April answered, yes. The company will text and call to make sure they contact someone regarding the alert.

Paul asked about the difficulties with increasing staff training. April replied they want Cybersecurity to pay for the training but Cybersecurity doesn't have the budget for training educators. Teachers have required trainings every year and hopefully we can make Cybersecurity part of that training April continued saying they have to partner with the teacher's union on training as well.

Asfaha mentioned at his job, one a month or every two months, they are required to watch a video regarding cybersecurity. April answered she is not able to make those videos mandatory yet.

Elizabeth asked is it possible to use the training as STEM clock hours. Mr. Del Valle says he is going to follow up.

Charnjit mentioned teachers get 32 hours where they need to learn technology and cybersecurity could be included in that.

# **Digital Learning Support**

Rafael presented an update on Digital Learning Support.

Elizabeth asked if they align with specific standard for expected outcomes. Rafael replied for educators they look at the Danielson Standard or Danielson Framework for Professional Practice. They also look at what a proficient educator should be able to do and what the observations are in the classroom. They do align with the Washington States Technology Standards. They also use and reference Principles of Effective Digital Learning.

The committee voted for Micah as Chair and Charnjit as Vice Chair. John motioned; Elizabeth seconded. The vote passed unanimously.
