Director Geary spoke about the Superintendent Procedure attached to this Board Policy action report. She stated that the change needed within the procedure will provide consistency in application and practice. Chief Academic Officer Dr. Diane DeBacker answered questions from the board.

Director Geary noted the C&I Committee recommendation. Director Burked moved to approve this item. Director Geary seconded the motion.

Acting Chief Counsel, Ronald Boy, approached the podium to explain to Directors that the motion to approve the April 24, 2019 minutes as amended still needed to take place.

Director Burke moved to approve the minutes as amended. Director Geary seconded.

#### **D. Introduction Items**

1. **[High School Science Instructional Materials Adoption](#)** (C&I, Apr. 23 & Apr. 30, for consideration) Approval of this item would accept the recommendation of the High School Instructional Materials Adoption Committee for instructional materials for all students taking 9th grade Chemistry A (CHEM A), 9th grade Physics A (PHYS A), 10th grade Biology A (BIO A), 10th grade Biology B (BIO B), and 11th grade Physics B (PHYS B), and authorize the Superintendent to purchase Carbon TIME as the core instructional materials for Seattle Public Schools' high school Biology A (BIO A) science classrooms, to approve the District-Developed Curriculum for BIO B as the core instructional materials for Seattle Public Schools' high school Biology B (BIO B) science classrooms, to approve the District-Developed Curriculum for CHEM A as the core instructional materials for Seattle Public Schools' high school Chemistry A (CHEM A) science classrooms, and to purchase PEER as the core instructional materials for Seattle Public Schools' high school Physics A and B (PHYS A and B) science classrooms, for an amount not to exceed \$1,034,132, covering licensing through school years 2019-20 through 2027-28. Director Geary noted the C&I Committee recommendation.

Dr. DeBacker spoke about a blended approach to the curriculum, teacher and peer development, and how it matches Board Policy No. 2015. Dr. DeBacker also spoke about the curriculum adoptions, provided historical context, and spoke on the committee work.

Directors spoke about access to technology for high school students.

Dr. DeBacker answered Directors' questions regarding which students will benefit from this item. She clarified that all high school grade levels 9-12 would receive the new curriculum.

Directors and Dr. DeBacker spoke about printing costs, which she stated that the costs would be at the building level budget for any printing needs.

Dr. DeBacker spoke about the cost of professional development during the last week of summer. Staff member Dr. Clover Codd provided some context regarding training days as covered by the Collective Bargaining Agreement.

Science Program Manager, MaryMargaret Welch spoke about online PDF materials, online access, using computers for learning, and technology use for teachers.

2. **Middle School Science Instructional Materials Adoption** (C&I, Apr. 23 & Apr. 30, for consideration) Approval of this item would accept the recommendation of the Middle School Science Instructional Materials Adoption committee for instructional materials for all middle school science classrooms in grades 6-8, and authorize the Superintendent to purchase AmplifyScience as the core instructional materials for all grade 6-8 Seattle Public Schools' science classrooms for an amount not to exceed \$2,069,686, covering licensing from school year 2019-20 to 2027-28, and an amount not to exceed \$565,857 for in-house professional development and collaboration and a 1.0 FTE Curriculum Specialist. (Minor edit 5/14: Intro and action dates updated on Board Action Report to reflect correct meeting dates.)

Dr. DeBacker spoke about the outdated materials and expressed that alignment across all grades is needed.

Acting Chief Legal Counsel Ronald Boy spoke about the testimony comments and clarified regarding gifts, costs, and anonymous donors. There have been products purchased by the district, but all gifts that were donated were under the allotted threshold.

Directors requested a statement from Amplify to clear up any prior miscommunication.

3. **Elementary School Science Instructional Materials Adoption** (C&I, Apr. 23 & 30, for consideration) Approval of this item would accept the recommendation of the Elementary School Science Instructional Materials Adoption Committee for instructional materials for all elementary school science classrooms in grades K-5, authorize the Superintendent to purchase AmplifyScience as the core instructional materials for all grade K-5 Seattle Public Schools classrooms for an amount not to exceed \$2,368,870 in a three-year phased-in purchase and implementation plan out of the FY2020 (2019-20), FY2021 (2020-21), and FY2022 (2021-22) budgets, covering licensing through school years 2019-2020 through 2027-28, and an amount not to exceed \$5,040,674 for in-house professional development and collaboration. Staff members clarified that elementary grade level students would have 0% online time for K-1 and about 10% of time online for grades 2-5 with the AmplifyScience Curriculum.

Dr. DeBacker and Ms. Welch explained that schools using the AmplifyScience program were given a waiver because the curriculum in other schools at the time was too outdated to get materials.

- **Amendment 1 to Elementary School Science Instructional Materials Adoption** (Directors Burke & Pinkham) Approval of this item would amend the proposed Elementary School Science Instructional Materials Adoption to adopt HMH Science Dimensions from Houghton Mifflin Harcourt for all elementary school science classrooms.

Director Burke expressed his reasoning for providing an amendment to the Elementary School Science Instructional Materials Adoption Board Action Report. Director Pinkham provided his concerns around technology access and screen time for Science Curriculum.

Dr. DeBacker, Ms. Welch, and Dr. Kinoshita provided responses to Directors' questions on the curriculum. Chief Information Officer, John Krull, provided insight on the ADA compliance issues with Houghton Mifflin Harcourt.
